## CODE OF ETHICS

This Code is established in accordance with the object of the F.B.F of M-F, Inc. It is presented as a guideline for the use of club members when buying, breeding, selling, and exhibiting French Bulldogs. Violators for this Code will be subjected to prompt action under Club Grievance and charge procedures.

1. Abide by the Constitution and By-Laws of the French Bulldog Club of America (FBDC), the French Bulldog Fanciers of Mid-Florida, Inc. (FBDFMF), and the American Kennel Club (AKC).
2. Keep accurate breeding records, registration papers and pedigrees.
3. Furnish records to each buyer of all shots, wormings, pedigree, and AKC registration and transfer documents, unless written agreement is made at the time of sale the papers will be withheld.
4. All services and sales agreements shall be mutually agreed upon in writing and signed by all parties involved.
5. Maintain the best possible standards of canine health, cleanliness and care.
6. All advertising shall be honest and not in any way be misrepresentative, fraudulent or misleading.
7. All dogs offered at stud and all bitches accepted for stud service shall be in good health and free from communicable diseases and disqualifying genetic faults.
8. No stud dog will be bred to any bitch whose owner is directly involved with any puppy broker, puppy mill or litter lot sales.
9. No French Bulldogs shall be sold to commercial facilities, puppy brokers, pet shops, puppy mills nor agents thereof.
10. All Members shall conduct themselves at all times in such a manner as to reflect credit on the sport of purebred dogs showing and French Bulldogs in particular
