### **For Immediate Release:**

Following an investigation that originated on September 8<sup>th</sup>, involving the fraudulent use of a patrons identification to make an account withdrawal at a local bank, Detective Sergeant Michael Ragucci issued a complaint for Damaris Arocho, Bronx, NY, age 41. She was charged with wrongful impersonation, exhibiting false documents as proof of identification and theft.

On October 14, at 12:03am, Officer Robert Schlossberg was patrolling Franklin Avenue when he observed a vehicle commit a traffic violation. Officer Schlossberg stopped the vehicle and the subsequent investigation led to the arrest of Jaclyn C Gerritsen, Maywood, age 23. She was charged with driving while intoxicated, reckless driving, failure to exhibit an insurance card, failure to exhibit a registration card, delaying traffic and failure to observe traffic lanes. Ms Gerritsen was released to a friend and is scheduled to appear in municipal court. Officer Kyle Ferreira assisted.

On October 14, at 11:49pm, Officer Kyle Ferreira was monitoring traffic on Goffle Road when he observed a vehicle pass his location with a violation. Upon stopping the vehicle, Officer Ferreira approached and immediately detected the odor of marijuana emanating from the vehicle. The subsequent investigation led to the arrest of Jake A Riley, Glen Rock, age 18 and Victoria E Calderon, Glen Rock, age 18. Riley was charged with possession of marijuana and maintenance of lamps while Calderon was charged with possession of CDS paraphernalia. Both were released and are to appear in municipal court. Detective Sergeant Michael Ragucci and Officer Michael Flim assisted.

On October 16, at 2:04am, Officer Michael Flim was patrolling Wyckoff Avenue when he observed a vehicle swerving in front of him. Officer Flim stopped the vehicle and the investigation led to the arrest of Jonathan E Warner, Ramsey, age 35. He was charged with driving while intoxicated, reckless driving and failure to observe traffic lanes. He was released to a family member and is scheduled to appear in municipal court. Sergeant Daniel Kellogg and Officer Kyle Ferreira assisted.
