The Restrictions shall be binding upon all parties having or acquiring any right, title or interest in this property and shall inure to the benefit of each owner thereof.

It is expressly understood and agreed that separate Restrictions have been filed for record for Meadow Lake, Section II, dated July 11, 1983 , and recorded in the Office of Harris County Clerk under File No. 104793, Deed Records of Harris County, Texas, which Restrictions, of course, will impress and subject the lots within Meadow Lake, Section II, to an annual maintenance and charge and assessment imposed hereby, and will make such subdivision subject to the jurisdiction of the Association. However, it is understood and agreed that the Association shall (i) enforce the restrictive covenants applicable to Meadow Lake, Section II, and (ii) pay for street lights and for maintenance of entrances to Meadow Lake, Section II (both clauses (i) and (ii) aforesaid to be done in the same manner as the Association does for Meadow Lake, Section I Subdivision). It is hereby understood and agreed that the Association shall treat Meadow Lake, Section II, in a nondiscriminatory fashion, on an equal basis, and in the same manner as Meadow Lake, Section I.
