*COMBO

~Any colored leotard, or tutu bodysuit. Tights tan, pink or black. Ballet shoes and tap shoes. Hair pulled back in pony tail or bun.

*PRE-BALLET

~Pink tutu leotard, pink tights, pink ballet shoes. Hair pulled back in tight bun.

*BALLET 1

~Black skirted leotard, pink tights, pink ballet shoes. Hair in tight bun.

*BALLET 2,3,4 & POINTE

~Black Company body suit or new Balera tank body suit (sold at JRD), pink tights, pink ballet shoes, ballet wrap skirt (black or pink). Hair in tight bun. Black undergarments ONLY.

*** ALL ABOVE CLASSES REQUIRE ITEM(S) PURCHASED THROUGH JRD BOUTIQUE**

CONTEMPORARY/MODERN/LYRICAL ~Any color bra top or leotard, booty shorts, tan tights, twyla leather lyrical shoes - 8 & under foot undies. Hair pulled back in tight pony tail or bun. (No socks or t-shirts)

JAZZ ~Any color bra top or leotard, booty shorts, tan tights, black or tan jazz shoes (thru JRD) Hair pulled back in tight pony tail or bun. (No baggy clothes)

BOYS HIP HOP ~ Loose fitting clothing, sneakers, baseball hat optional

GYMNASTICS ~Acro-tight bodysuit or bra top and booty shorts. If hair is long wear Bun, of not tight pony tail. No jewelry ever!

TAP ~Tap shoes (from JRD), Bodysuit, tights, booty shorts. Hair pulled back tightly. Tap shoe style will vary per level.
