## How to Order

BASE SADDLE INCLUDES: Tree of your choice; up to $16^{\prime \prime}$ seat length; quilted seat in brown; your choice of dee $\&$ string or buckle rope strap; your choice of horn style \& size; Chevenne roll on cantle; round skirts; smooth, rough out, or latigo finish; up to 2 letters or one brand; your choice of strings with leather conchos.
BE SURE TO ADD: Two (2) latigos: your choice of front \& rear cinchas; two (2) rear billets of your choice; and stirrups of your choice to complete the saddle. Include the price of these items on the order blank. Add the extras you want.
FOR AS LIGHTWEIGHT SADDLE AS POSSIBLE, specify swell or slick fork only (the others weigh more), and regular horn only (it is not guaranteed for roping). We recommend no more than partial stamping, as this tends to "cup" the leather. If you do order more stamping, we must use heavier leather. To keep weight to a minimum, we suggest No. 40 rear billets, No. 15 front cinch, and No. 61 rear cinch. Order 2" stirrups.
THE FOLLOWING LINES MUST'BE FILLED IN: Seat length, fork style, horn style and size, finish. If you do not designate these, we must write and find out your needs which could delay the order.
ALL OTHER LINES WILL DEFAULT AS FOLLOWS: Weight - medium; Sear - dark brown quilted; withers height - medium; rope strap -dee \& string on fork; Cantle - Cheyenne roll; Rope edge - none; Skirts - round; Silver items - none; two (2) latigos; No. 15 front cinch; No. 62 rear cinch; No. 20 rear billets; Three (3) inch laced leather covered stirrups. (Lines which default to a specific item should be marked "NONE" if this is the case).
PLEASE DO NOT MARK OUT LINES ON THE ORDER BLANK or write in superlluous words such as "included" or "no charge", as this order is used for our shop work order, and these only serve to add confusion and must often be recopied which is the single largest cause of oversights and errors.
