 - b. There have been 18 drops with 17 receiving refunds; one didn't want a refund.
 - c. There are 5 players on the U06B waiting list, 3 players on the U08G waiting list, 1 player on the U12G waiting list, and 5 players (3 girls, 2 boys) on the U14C waiting list.
 - C. Treasurer Report:
 - a. Laura Avila reported the following:
 - i. Current checking balance of \$42,064.77.
 - ii. Current savings of \$3,040.96.
 - iii. Total balance is \$45,105.73.
 - b. BRYSL received a bill from Cal South for August's activity.

- c. Two Score invoices for uniforms and referee equipment came in.
- d. Laura Avila paid \$5,100 to the Condors for our tickets and we will receive a refund check in that same amount from them in a few weeks.
- e. Laura Avila presented a Profit & Loss YTD Comparison and a Profit & Loss Budget YTD Overview.

D. Pictures/Sponsor/Fundraiser/Handbook Report:

- a. So far, 20 teams have already provided sponsorships with one team providing two sponsorships for a total of \$6,265.00.

E. BCSD Fields/Golf Cart/Trailer/Storage Report:

- a. Pat Hall got the liability insurance forms for the school fields.

F. Coach Report:

- a. Carolyn Morales and Crystal Villa thank all of the Division Directors for helping their coaches.
- b. There needs to be more communication from the Division Directors to Carolyn Morales and Crystal Villa.
- c. A U12 coach needs help with getting volunteers; Juan Bermudez coaches his team at the same location as this U12 coach so he will help her out.

- e. Crystal Villa has handed out all but two team's uniforms.
- f. Game cards were given out with the uniforms.
- g. If coaches have a problem reaching players, they need to contact their Division Directors for guidance and extra help.
- h. There are three coaches that can't pass the live scan. Also, 14 coaches still need their coach's license, 6 coaches need their concussion training, and 3 coaches need their safe sport training.

- a. The league is short on referees. There will be a center referee on each game and then we will have to fill in the sideline referees with parents.

- a. All uniforms came in. Crystal Villa will only order new uniforms if they are too small for players.
