- I Meeting:** Meeting called to order at 6:35 pm. September 2016 meeting notes were motioned for approval by Carolyn Morales & seconded by Mike Uribe; motion passed unanimously.
- II Visitor/s:** The board welcomed Elmer Hall and Amparo Alvarenga.
- III League Commissioner Report:**
- A. KCSF Meeting Report:
 - a. There have been parking issues out at the soccer park with people parking in non-parking spots. If the board sees any of our parents parked illegally, tell them to move or they will be towed at the owner's expense.
 - B. Cal South report:
 - a. The Commissioner's Cup has been scheduled for December 10th and 11th and Districts 6 & 7 (northern LA) will be participating in it.
 - C. BRYSL Nonprofit report:
 - a. Nothing to report; we are in good standing.
 - D. BRYSL & PYSL Friendly Games:
 - a. Danny Moreno will cancel the fields we have on hold with the KCSF.
 - E. Commissioner Report:
 - a. The season has started off very well. It is nice having the 5th time slot for games so the board can be more available to the parents.

- A. Board positions open:
 - a. Nothing to report.
 - B. Registration report:
 - a. There are no more registrations for the 2016 season.
 - b. Early-bird registration will be from October 30-December 31. The fee is \$70.00.
 - c. Laura Avila motioned, Mike Biezd seconded, early-bird registration will be \$70.00 from October 30-December 31. The cost will then rise to \$75.00 from January 1-June 30. After July 1, the cost will be \$80.00; motion passed unanimously.
 - d. We now have registration forms in both English and Spanish.
 - C. Treasurer report:
 - a. Laura Avila reported the following:
 - i. Current checking balance of \$27,731.16.

- ii. Current savings of \$6,036.28.
 - iii. Total balance is \$33,767.44.
 - b. Division Directors need to keep pushing sponsors; only 60% of teams have sponsors.
 - i. Pat Hall will send the sponsor list to the Division Directors so they can let the teams know.
 - c. Laura Avila will pay the Score bill (\$5,000.00) and the Cal South bill (\$860.00).
 - i. The only outstanding invoices that will need to be paid are the pictures, trophies, and the remainder of the fields bill.
- D. Pictures/Sponsor/ Fundraiser report:
 - a. Make-up picture day is October 9th, 10-12 on Field 5. Individual pictures only.
- E. Fields/Golf Cart/Trailer Report:
 - a. The batteries on the golf car were corroded. Mike Uribe took the cart to All Carts and they did not charge him a bill, so we will list All Carts as a sponsor for the league as a thank you.
 - i. Mike Uribe will get the battery cleaned every year.
 - b. The trailer and storage are all good.
 - c. There will be no more practices at Chipman on Thursday nights because of issues with players/parents. One player urinated on a building and a parent brought alcohol to their child's practice.
- F. Coach report:
 - a. Mike Biezd will schedule the midseason/ratings meeting for October 26, 6:30pm at Rusty's on Auburn for the U06 and U08 Divisions. The U10-U19 Divisions will be on November 2, 6:30pm at Rusty's on Auburn.
 - b. There was a coach that was sleeping at the game he was supposed to be coaching. Mike Biezd will talk with him.
 - c. There was an issue with a referee and the parents at a game this week. The referee asked the assistant coach (head coach was not present) to pull a player back who was scoring all the goals for their team. The parents said the referee has no right to tell them where to play the player since the score was only 4-1. The parents then recorded the referee and the altercation and put in on our Facebook page with a negative comment about BRYSL and the referee. After speaking with the head coach, everything was taken care of, and the coach will speak with the parents about the post they made and will ask them to refrain from posting anything else negatively about the situation since we have taken care of it.
- G. Referee report:
 - a. There are currently 60 referees.
 - b. Mike Uribe talked with the referee who had the incident with the parents about moving a player into another position. Mike told him because the score was not a large enough difference, he should not have said anything to the coach. The referee understood, and apologized.
- H. Purchasing report:
 - a. Christina Bowles will request all of the same schools we practiced on this year on November 1st.

- b. Christina Bowles double-ordered our uniforms when she was putting in a new order. BRYSL has decided to keep the order and we will just have the same uniforms again for next year as we do this year.
 - i. Score has said we will not have to pay for the bill until the next year.
