Dance Academy Policy Reminders

Keep the dance floors clean by carrying the dance shoes in a bag.

No powder or lotion is allowed in the dance studios.

All dancers must wear their hair in a bun for all classes. Jewelry is not allowed.

No food, candy or drinks allowed in studios.

Parents are expected to pick up their child promptly after class.

We do not send out a monthly bill or a statement. Tuition is due the 1st of the month. A late fee of \$25.00 is charged after the 10th of the month for any unpaid tuition. Tuition can be mailed to 5240 N. 10th Street, McAllen, Tx. 78504 if necessary. Dancers are considered enrolled unless the front desk has been notified otherwise. Students will be dropped after 2 months of absences and must re-enroll to return to class. There is an annual registration charge of \$30.00. All holidays are calculated into tuition plan.
