2020 Chattahoochee Mountain Fair Market Hog Show Rules & Regulations

- **All entry fees must be paid at check-in. NO PAYMENT, NO SHOW.**cash, cashier's checks and money orders will be accepted.**
- **Please have your pass and vehicle pass for entrance into the livestock gate.**
- ***** The Livestock Gate will be CLOSED at 5pm. If you are hauling tack, please make sure you are inside the gate before 5pm.**
- Exhibitor, parent & teacher/agent must sign entry forms. Forms will be returned if it is not signed.
- **Only 2 entries per exhibitor.** **There will be no refunds if more than 2 have been entered for one exhibitor.
- Hogs must arrive and be checked in between 2pm and 5pm the day of the show.
- Exhibitors must have official health papers to be eligible to show.
- The market hog show is open to students in Habersham, White, Stephens, Towns, Banks, Hall, Union, Rabun and Jackson Counties.
- All hogs will be shown by weight.
- All hogs must be owned by the exhibitor on or before August 1, 2019.
- Exhibitors must show their own animal in showmanship class and in weight class unless the exhibitor has more than one animal in the same class.
- The show committee reserves the right to change, combine, or delete classes with insufficient entries.
- **There will be limited pen space available. It will only be a first come first serve basis. No Holding Pens.**
- The decisions made by the show committee regarding show rules and regulations will be final.
- All complaints must be filed with the show committee on the day of the show. Exhibitors must fill out a complaint form explaining grievance. These will be available at the show desk the day of the show.
- **Due to COVID-19, the Chattahoochee Mountain Fair will follow all necessary guidelines set forth by the Governor, the CDC and the local government. A list of guidelines will be sent with your fair passes.**
