## E. Ordinance No. 24 Section 6

Discussion was held about adding the following working to Parking Ordinance; There shall be no unauthorized parking of vehicles on any Village right-of-ways, and wit the exception of receiving an discharging passengers or loading or unloading merchandise, no commercial vehicles shell be parked or stored on any residential property.
