

ORDINANCE NO. 49

AFFIDAVIT OF PUBLICATION

ORDINANCE ESTABLISHING BUILDING PERMIT REQUIREMENTS AND CHARGES FOR THE CITY OF NEW MUNICH

THE CITY COUNCIL OF THE CITY OF NEW MUNICH HEREBY ORDAINS:

Section 1. Effective April 1, 1982, the City of New Munich shall require the purchase of a building permit for all new construction and for all additions, remodeling, or repair to existing structures.

Subd. 1. The rate and charges of such permits shall be established by the City Council of New Munich and may be obtained at the office of the City Clerk.
