Owner must complete Part A. Applications must be submitted for review to the City Clerk, 5500 S. 77<sup>th</sup> Street, Ralston, NE 68127, together with (a) copy of Owner's valid Class O operator's license; (b) proof of liability insurance coverage for the vehicle specifically listing the vehicle as reference by year, make model, and serial number and in the amounts required by Section 5-533 of the City's Municipal Code; (c) payment of the registration fee required in Section 5-532. Applications will only be accepted by hand delivery. Incomplete requests will be refused.

Upon approval, the City will complete Part C below and provide a copy of this Application to the Owner, together with two registration stickers. The registration stickers must be affixed to the Golf Car Vehicle in accordance with Section 5-532 of the City's Municipal Code. Registration is only valid for the calendar year in which it is issued. The registration fee will not be prorated and is not transferrable. The City reserves the right to revoke the registration if the Vehicle Information provided by Owner in Part A is inaccurate or if the Vehicle otherwise fails to meet the definition of Golf Car Vehicle in Section 5-529 of the City's Municipal Code. No refunds shall be allowed for any reason.
