### SPRING IS HERE Learn Before You Burn

To burn within the city limits, you must have a burn permit issued by the Cascade Rural Fire District. 208-382-3200.

NO BURNING is allowed May 10th thru October 20th.

Burn piles of vegetative yard debris should be no more than 3' in circumference.

Be considerate of your neighbors, pay attention to wind direction. Have a hose handy.

### **DUMPSTER DAYS are approaching!**

May 28 thru June 8, 2022. Vegetative yard debris only. No plastic bags.

A single dumpster will be located in the parking lot across from the fire station at Pine and Front St.

If the dumpster is full, and it is between 9 am and 4 pm, a new dumpster is likely on route.

Do not leave bags or piles of yard debris.



## Ever wondered where your water comes from?

#### City of Cascade Water Source

Ground water, which is obtained by drilling wells, is water located below the ground surface in pores and spaces in the rock, and is used by approximately 78% of community water systems in the United States, supplying drinking water to 32% of community water system users. EPA also estimates that approximately 15% of the U.S. population relies on private ground water wells



## Ever wondered where your waste water goes?

When the wastewater flushed from your toilet or drained from your household sinks, washing machine, or dishwasher leaves your home, it flows through your community's sanitary sewer system to a wastewater treatment facility.
