I agree that my use of the facilities of Burgundy Hollow Horse Trials and any activities on the lands of Michelle McBride Casale, Burgundy Hollow Farm, Inc. or Thomas E. McBride, Inc. (hereinafter the "Farm" are subject to the conditions in this release).

I agree to wear protective headgear when riding or driving that passes or exceeds the ASTM/SEI standards, with harness attached and I agree to wear a body-protecting vest that meets or exceeds current USEF rules and approved medical armband when riding or driving in cross-country activity.

I understand that the activities of eventing and horseback riding as well as any activities conducted on Farm property are high risk activities and that my participation in these activities may also involve participation in an "equine activity" as defined by Pennsylvania laws and are wholly at my own risk.

I understand that my participation involves all inherent risks associated with the dangers and conditions which are an integral part of equine activities including, but not limited to, the propensity of equines to behave in ways which may result in injury, harm or even death to humans, equines or other animals; the unpredictability of equine reaction to sounds, sudden movements, smells, unfamiliar objects and/or persons or other animals; hazards related to surface and subsurface conditions; equipment failure; tack failure; use of any mode of transportation while on Farm property; the loading and unloading of equines; collisions with other equines or objects; and the potential of a participant to act in a negligent or unskilled manner which may contribute to injury to the participant or others, including failing or inability to maintain control over the animal.

I agree, by participating in these activities, to assume responsibility for those risks, and I release and agree to hold harmless Michelle McBride Casale, Thomas V. Casale, Burgundy Hollow Farm, Inc., Thomas E. McBride, Inc., Burgundy Hollow Horse Trials, the activity organizer, organizing committee, officials, their officers, agents, employees, and the volunteers and the owners of any property on which said activity is being held, from all liability for negligence resulting in accidents, damage, injury or illness to myself and to my property, including the horse(s) which I may ride and which may accompany me.

I understand and agree that Michelle McBride Casale or the organizer of this activity has the right to cancel this activity; to refuse any entry or application; to require and enforce the wearing of safety or other attire and the conduct of riders, horses and visitors; and to prohibit, stop or control any action during the activity deemed to be improper or unsafe.

I agree that as a condition of and in consideration of my use of the Farm, Burgundy Hollow Horse Trials, Michelle McBride Casale, Burgundy Hollow Farm, Inc. or Thomas E. McBride, Inc., may use or assign photographs, videos, audios, cablecasts, or other likenesses of me and/or my horse and I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.
