LOCATION

Trial rings will be in Building "B". This is the second building as you come into our grounds.

FLOORING

Flooring is turf. The turf area will have a tarp cover to protect the turf flooring.

CRATING

Crating space will be available in Building A. All dogs must be on lead or crated at all times unless actively working.

FOOD

We will have a potluck all 3 days. We will be providing the main course dishes, but please feel free to bring a side dish or dessert to share. There are also various fast food restaurants within 1 mile of the facility, Alum Creek Rd. and 270.

AWARDS

For Senior & Master classes, ribbons will still be awarded as they would be at a regular barn hunt trial (brown Q ribbons, placements and High in Class). We will also still have title ribbons available including our special Ratch and Ratch X ribbons. Additionally, Regional Qualifier ribbons will be provided for each competitor that receives a qualifying score in any class at the Regional Event. In Hurdles, in addition to Regional Q Ribbons, 1st - 4th placements are awarded in each height and each round, as well as High Hurdles Round 1 and Round 2 and overall High Hurdles. In Teams, in addition to Regional Q ribbons, the 1st - 4th place teams each get a ribbon, as well as High Team for the first place team.
