HAPPY NEW (FISCAL)YEAR!

I have spent most of my space in presidential messages asking you for help or money. Let's take a different approach this month and explain what you can get from the club in return.

The Woman's Club of San Antonio is a 501(c)3 non-profit organization. As such, we have both benefits and obligations. We fall under a different tax code, and we do not pay sales tax on items we purchase for the club. When we pay for the luncheons you enjoy, we do not pay sales tax on them. We file taxes in a manner different than you or I do on our personal income taxes, and the amount we have to pay is very little. Because of our status, we qualify for places of recognition on such community committees as the Fiesta San Antonio Commission and the Women's Federation. Some organizations will not allow anyone who is not a 501(c)3 to join.

But we also have obligations to meet to maintain our tax designation. We support community education. We provide scholarships totaling \$10,000 to the Women in Transition program at San Antonio College. We have added other types of support to the GED program through the Empowerment Center there as well. We support three named charities: WINGS, the Volunteer Services Council at the State Hospital, and Respite Care of San Antonio. We further support other specific charities each month at our meetings. But you likely know all of this already. The question is, "what's in it for ME?" Here is a great example: For the six members who helped prepare and serve at the GED luncheon in May: your mileage from your home to the WCSA and back is tax deductible. Whenever you come to work for the good of the club, your mileage can be deducted on your tax return. When you donate an item to the club, give to the Golden Book, buy a brick for the garden, bring food or refreshments for a program; it is tax deductible. Keep in mind that if you get something in return (quid pro quo), it is NOT tax deductible. You cannot deduct the luncheon fee you paid for your lunch or for the silent auction item you purchased or for items you bought in our wonderful Boutique. These actions all help the club, but you got something out of it and Uncle Sam thinks that you have benefitted enough-so no further tax deduction.

So, keep good records. I have a manila folder in my desk drawer for my receipts for items that have benefitted the club. At the end of the year, I add them up and submit them to my CPA. He is surprised that this is the only time I am truly organized in my finances!

To all of our Members: I am so thankful for you and all you do for our club. As we start the new club year (July 1), may it be filled with wonderful new ideas and the continued generosity of its members.
