The financial statement for month ending April 2017 was approved on a motion by Michael Rea with a second by Ron Jones. A roll call vote was taken: Dugger-yea, Jones-yea, Rea-yea, Flemons-yea, and Mayor Tucker-yea.

The Police Activity report for the month ending April 2017 was presented to the council and discussed.

Discussion was held concerning Ordinance 2017-01, an ordinance to regulate the firing of firearms in the town limits of Somerville, AL. Motion did not carry.

Resolution 2017-02, a resolution to provide for the Town of Somerville Annual Participation in the "Back to School Sales Tax Holiday" was passed on a motion from Sheena Dugger with a second by Carl Flemons. Resolution 2017-03, a resolution that states that the Town of Somerville has reviewed the Municipal Water Pollution Prevention Annual Report, was passed on a motion by Ron Jones with a second by Michael Rea. A roll call vote was taken: Dugger-yea, Jones-yea, Rea-yea, Flemons-yea, and Mayor Tucker-yea.

A sewer update was given by Ron Jones. A motion to pay up to \$2500 to install a bypass valve on the High Street Pump Station was made by Ron Jones with a second by Carl Flemons. A roll call vote was taken: Dugger-yea, Jones-yea, Rea-yea, Flemons-yea, and Mayor Tucker-yea.

A motion to pay the monthly bills was made by Michael Rea with a second by Sheena Dugger. A roll call vote was taken: Dugger-yea, Jones-yea, Rea-yea, Flemons-yea, and Mayor Tucker-yea.

A motion to trade the Expedition plus \$750 to Cody Maples for a 1998 Ford Ranger to use as the vehicle for the mosquito sprayer was made by Carl Flemons with a second by Sheena Dugger. A roll call vote was taken: Dugger-yea, Jones-yea, Rea-yea, Flemons-yea, and Mayor Tucker-yea.
