Safety Reminders

Parking Enforcement

The CCSO patrols in Valencia Lakes are issuing parking tickets to any vehicle parked blocking a sidewalk or illegally parked! If you're parking on the grass between the sidewalk and the road, you are parked on community property, may cause damage to irrigation systems and are subject to fines and towing!

No overnight parking in clubhouse parking lot without a permit (obtained through the HOA office). Violators may be subject to having their vehicle towed!

Power Washing Sidewalks & Driveways

Please remember to keep your sidewalks & driveways clean to provide a safe environment for all of our residents & visitors.

There are many important reasons why it's essential to maintain your driveway and other concrete based surfaces through pressure washing. It can't be stressed enough how important it is to keep those outside surfaces clean and sanitized as much as possible.

- **Curb Appeal:** wouldn't your guests, neighbors & potential home buyers appreciate seeing clean surfaces?
- Safety Risk: the micro organisms that grow on sidewalks (black mold, mildew and green algae) tend to look darker and a bit thicker each time it rains; they soak up water and tend to become slippery. The situation is a "slip & fall" just waiting to happen on your property.
- Health Hazard: the micro organisms can spread quickly and easily from outdoors to indoors just by walking on them.

Pool Safety

Owners with damages to a pool fence or lanai cage should take immediate action to secure the pool per the below information from Collier County. Also see page 5.

54.2.17.1 Outdoor swimming pools. Outdoor swimming pools shall be provided with a barrier complying with Sections 454.2.17.1.1 through 454.2.17.1.14.454.2.17.1.1

The top of the barrier shall be at least 48 inches (1219 mm) above grade measured on the side of the barrier which faces away from the swimming pool. The maximum vertical clearance between grade and the bottom of the barrier shall be 2 inches (51mm) measured on the side of the barrier which faces away from the swimming pool.

Where the top of the pool structure is above grade the barrier may be at ground level or mounted on top of the pool structure.

Where the barrier is mounted on top of the pool structure, the maximum vertical clearance between the top of the pool structure and the bottom of the barrier shall be 4 inches (102 mm). 454.2.17.1.2

The barrier may not have any gaps, openings, indentations, protrusions, or structural components that could allow a young child to crawl under, squeeze through, or climb over the barrier as herein described below. One end of a removable child barrier shall not be removable without the aid of tools.

Openings in any barrier shall not allow passage of a 4-inch diameter (102 mm) sphere.

Community Rules/Reminders

Nuisance & Vandalism

If you experience vandalism or have a nuisance issue such as excessive noise by a neighbor, notify the CCSO (Collier County Sheriffs Office) at 239-252-9300, the non-emergency number. **Do not call 911 unless it is a true emergency.** Once reported to CCSO, notify the HOA office where your information will be forwarded to Vision for a Nuisance Violation Letter. Upon the third visit to a residence for a complaint, CCSO will issue the occupants a ticket. The HOA is not a law enforcement agency.

Do not cut the litorials planted along the lake bank

Homeowners, please talk to your landscaper and let them know not to cut, weed whack or remove the littorals planted along the lake bank. The plantings are part of the lank bank erosion project. Since this is a lake bank mitigation issue, the homeowner will be held responsible for the cost of replacement of any littorals being removed.

WARNING: Do not let your children or pets play near the lakes

If an alligator becomes a nuisance, **you**...the resident must call the Florida Fish and Wildlife at 866-FWC-GATOR / 866-392-4286. They will ask **you** questions about size and nuisance issues.

Key Fobs

Upon selling your home in Valencia Lakes, the Key Fob may be transferred to the new owners, whether purchased from you or simply passed on as part of the real estate transaction. However...upon the sale of your home, the Key Fobs will be deactivated and then reactivated upon the new owners registering with the HOA at the Clubhouse office.

Read & Heed

Have you noticed the 5 MPH sign that has been added on the right side of the street, when exiting at main exit at Randall? When the exit metal gates are open, please drive 5 mph when passing through. This gives the loop detector sensor time to determine there is a vehicle passing by the exit metal gates and to open up. If you exceed the speed limit, your vehicle may be damaged by the metal gate.

Please be a responsible dog owner; pick up after your pooch

The HOA office has received several complaints about residents not cleaning up after their dog leaves a "present."

Packages being stolen from homes after delivery.

We have received a few reports on UPS packages being stolen from homes after delivery. Here are a few tips to deter this sort of crime from happening.

- Choose a shipping option so you have to sign for delivery.
- Ship the package to another location if you aren't generally home such as your office or a neighbor/friends' home.
- Leave special instructions where to deliver packages if you are not going to be home.
- Choose "delivery pick up" so they hold your package rather than leave it on your doorstep.
- If you live in a building, set up a way to have neighbors hold each other's' packages rather than leave them in a common area.
- Insure your packages, just to be safe.
- · Get a mailbox at the post office or a local shipping store

If a package is stolen please call the Collier County Sheriff's Office at 239-252-9300 and report the theft.

Post-Irma Pool Barrier/Screen Enclosure Repair and Replace Policies

Many pool barrier and screen enclosures were damaged or destroyed by Hurricane Irma. To address this recovery period, the Collier County Building Official has established the following policies for the repair and replacement of these enclosures.

Please note that the repair or replacement of your pool barrier/screen enclosure should be a priority. Even a pool that is empty poses a life safety threat when there is no pool barrier in place. Until you can replace or repair your pool barrier/screen enclosure, a temporary contractor safety mesh can be erected. The temporary mesh may be purchased at your local home improvement store.

- No building permit is required for a pool barrier/screen enclosure that was damaged less than 25 percent.
- A building permit is required for a pool barrier/screen enclosure that was damaged more than 25 percent and less than 50 percent, however, it can be repaired to the Florida Building Code standards that were in place at the time it was constructed (same materials, loading, etc.).
- A building permit is required to replace a pool barrier/screen enclosure that was damaged more than 50 percent and the new pool barrier/screen enclosure will be required to meet the 5th Edition Florida Building Code requirements.
- Spot surveys will be required before a certificate of completion is issued. Spot surveys that indicate nonconformance with setbacks will be researched by the Growth Management Department and approved on a case-by-case basis.
- No permit is required to re-screen a screen enclosure.



Building permits addressing damages due to Hurricane Irma will be made a priority. To apply for a building permit, visit the Growth Management Department at 2800 N. Horseshoe Drive, Naples, Florida 34104 or the Immokalee Permitting Office at 310 Alachua St., Immokalee, Florida 34142. You can also apply for a building permit online at: http://cvportal.colliergov.net/cityviewweb.

If you have any questions regarding the level of damage to your pool barrier/screen enclosure or questions regarding permitting, please visit the Growth Management Department, address noted above, or call to speak with staff at (239) 252-

2400. Residents of Immokalee can visit the Immokalee Permitting Office, address noted above, or call to speak with staff at (239) 252-5733. All permitting offices are open from 8 a.m. to 5 p.m. Monday through Friday.

Please be advised that permitted repair work and the construction of a new pool barrier/screen enclosure must be done by a licensed contractor or as an owner builder, as defined by Florida Statutes.
