- Compatible with Internet Explorer 6.0 or greater and Firefox 3.6.13
- Allowing access to the following case types:
 - Civil Action (CA), Conservatorship (CN), Delayed Registration or Correction (DB), Deposit of Will (DW), Estates (ES), Guardianship of Incompetent (GI), Guardianship of Minor (GM), Marriage License (ML), Minor Settlement (MN), Name Change (NC), Trust (TT), Wrongful Death (WD)

Search Screen:

"Search By"

This option will determine the type of criteria you plan to provide. You can choose to search by Case Number, Name or Bar ID.

"Search For"

This option will determine the type of data that is displayed in the search results. You can choose Cases, All Events or Upcoming Events.

"Search Results"

After clicking Apply and if there are matching records, a listing of search results will display at the bottom of the page. Each record will display a few general properties and will be available to view by clicking the magnifying glass in the View column. This will open the View Case Screen for displaying detailed information.
