The Board reported on meetings they had attended. Hashman reported on the meeting that Batterman missed.

The Elected Officials and County Board discussed salaries for the upcoming term from 2019-2022. Metz said he was considering a 1 ½% cost of living increase. The amount that the elected officials asked for was to get closer to the recommended median for a Class II County which started the Clerk, Treasurer, Assessor and Clerk of the District Court at \$55,000 and a 4% increase each year after that. The amount for the Sheriff would be at 125% of that and the Attorney at 150% of that amount. Batterman and Sterkel said they were thinking of a 2% increase. The Elected officials presented an alternative with a straight 3 or 4% increase. The Board said they will review these and decide on the last meeting in December.

Mark Masterton, NIRMA Board member, presented the statistics for Morrill County. Masterton explained the insurance pool with NIRMA and all of the services that are offered and how much Morrill County has utilized these services.

The Board discussed the Juvenile Detention Center with Masterton and Rodak said he would like to know why it is possibly being located in Scotts Bluff County which is not centrally located. Hashman said he was interested in sharing services with other counties. Tony Armer said he was looking for space in Bridgeport to locate. Discussion was held regarding the detention center and the cost of taking juveniles to Madison County.

Eva Draper, Head Custodian, reported on the elevator being down and the possible cost of replacing the board that is not working. Julie Schildt, Clerk of the District Court, reported that two toilets in District Court need to be replaced. The Board told Draper to get in touch with a plumber and get them ordered.

There being no further discussion, Chairperson Metz adjourned the meeting at 9:44 A.M. Next meeting will be Tuesday, December 12, 2017.
