## PRESIDENT'S MESSAGE BY BILL ROBERTS

First, I'd like to give a huge thank you to our community members who responded to the call for help from our neighbors in the Ft. Myers area devastated by Hurricane Ian. We had four caravans organized by residents and members to take relief supplies collected from the community of Hernando Beach. We heard firsthand from them what the conditions were like when they shared photos and short personal testimony from survivors – emotionally draining for all to see such suffering and destruction of daily lives and loss of life.

Second, are you prepared for the next hurricane? What will make you decide to stay and what will make you evacuate? Where will you go? Do you know where the shelters are in Hernando County? These are the kinds of questions you need answer before the “critical time point”, (too late to leave and too dangerous to stay). The number of sources to help us make that decision on TV, online, radio and print are increasing. We can get over-informed with reports. There is so much information to help guide us but it can also make us timid to make a decision till we pass the critical time point.

As we say in aviation – the best place to plan is at ground speed ZERO. Collect your sources of information and support before the hurricane hits or threatens to hit. Then build your game plan: what to do to safeguard your property, what to take with you, where will you go, how long will you stay gone? So, before the next hurricane is spotted off the coast of Africa, build your plan, make your decision points and be prepared to execute the plan to stay safe and alive.

On the lighter side, our own resident artist Linda Tartaglione completed the HBPOA grant from the Hernando County Fine Arts Council. The membership was invited to the unveiling. Gordon Wolf and Kenny Lewis hosted at 4545 Shoal Line Blvd at 1pm on 7 October. We had a great turnout

**2022 UF/IFAS Coastal Cleanup.** A big shout out to our HBPOA membership for their sponsorship and participation. I want to share with you the results of this successful event. Overall, there were **266 volunteers** who participated in the coastal cleanup. The UF/IAS ordered 175 t-shirts to give out and they were all gone by 8:30am! The trash sorting station not only logged the types and amount of trash, but also weighed the debris this year. We estimated that **900 pounds of trash** and **140 pounds of recycling** was collected between Bayport and Aripeka (**1,040 pounds** in trash total).

Member Survey - The HBPOA Board decided to have a discussion about the Preserve with the members at a meeting and take their input to the BOCC. I closed the discussion because we'll never have enough members in attendance to accurately capture a consensus.

Lots of emotion out there regarding the Preserve and justifiably so however, much of it is purposely directed at the HBPOA as a foil because some think people need to focus their anger on something as the cause of what is happening to the Preserve. I heard it again - "it all started when you had the 2016 Roundtable". Many do not know that all the proposals have been heard before and are part of the county record since 2014/2015 and maybe even before that. But now the BOCC is willing to spend the time and money to bring the concepts to fruition.

The purpose of the survey is to capture HBPOA member's only opinion/position on pro-

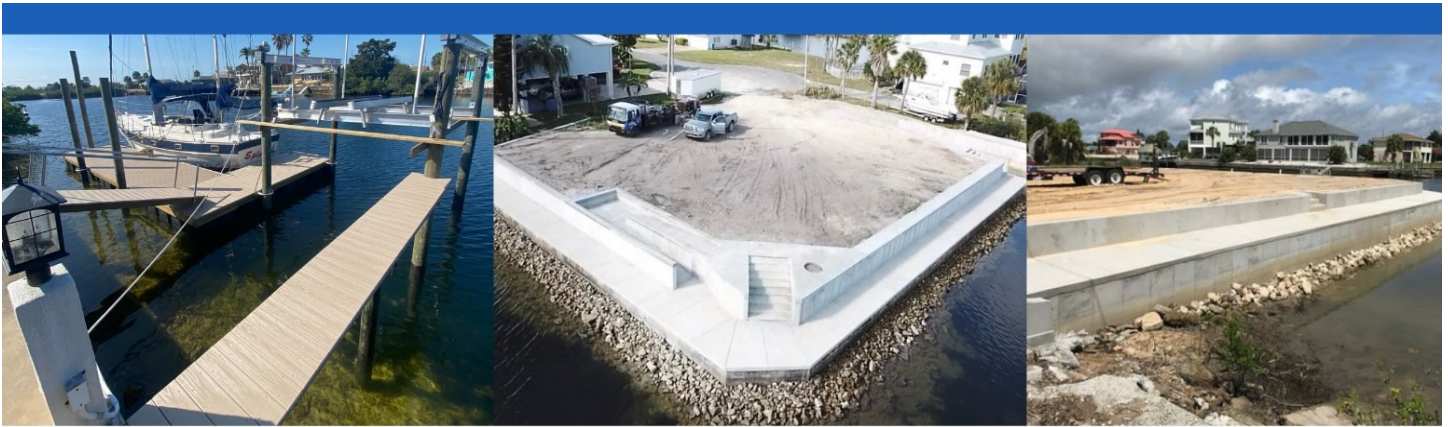

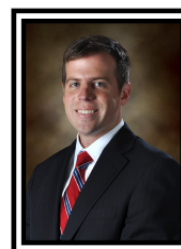

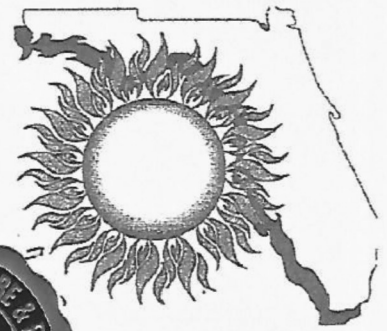

### OCTOBER FISHING REPORT

Fall is in the air and the water temperature is dropping. This will make for excellent gag grouper fishing from now until the end of December. Gag grouper can be caught in all depths of water; 6 to 40 feet will be the target depths right now. Live and dead baits work for grouper. I'm a live bait and lure guy myself. Casting plugs for shallow water grouper is probably the best. In my opinion, seeing big gags eat a plug or sky bust a tuna popper is just unbelievably awesome! Try not to run your spots over especially in shallow water under 20 feet. They can get spooky when driving over a rock or ledge.

Live baits for my trips are pilchards and pin fish, rigged on a 60-80-pound leader and 6/0-8/0 circle hook. For lures, nothing is better than the Rapala fmag 18 floating plugs. All colors work great.
