Message from the Board President

As this fiscal year draws to an end, I would like to update GHC residents on some of our many accomplishments this season, 2018-2019.

Grounds

As everyone can see, there has been an appreciable improvement in our grounds over the past year. Our main grounds keeper, Jim, and the grounds committee are working very hard to bring our grounds back to the standard that we expect. We aren't there yet, but we are well on the road to recovery.

Villas 4-8 Restoration

These renovations have begun and are taking a little longer than we had hoped. We are working with the Engineering firm and the General Contractor, and expect this work to be completed within the next few weeks.

Budget & Other New Projects

Our Treasurer, Fred Moffett, did an excellent job this past year of monitoring and keeping our budget in line. With a complex of our size and age, we always seem to have new issues arise. It is recommended that manholes and waste infrastructure need to be pumped and cleaned every 3-4 years. Our manholes and waste infrastructure have <u>never</u> been cleaned in our 40-50 year history. On top of that, the common uses of Sink Garbage Disposal systems dump tons of food waste into our system, which is a breeding ground for rodents and bugs. Many buildings are presently dealing with the intrusion of these pests in condos. We are commencing two projects to combat these issues.

- 1. In phase one (Jasper Drive), D&D Excavating Inc. will be installing "Back Check Valves" on the sewer lines to prevent rodents and bugs from entering buildings.
- 2. Also in phase one (Jasper Drive), "All South Underground" have been contracted to clean the sewer lines and manholes in this area.

This section has been most heavily affected by rodents and bugs. When phase one is complete, we will have a better understanding of the condition of our sewer lines and manholes. We will then use this information to more accurately forecast the requirements to move forward with the next phases to complete this work for all of GHC ASAP.

Summarize Your Condo

As a reminder for all of the Snowbirds and others that are leaving for an extended period of time, please "summerize" your condo. This means turning off the water supply line, adding bleach to your toilet bowls, and placing Saran Wrap over your toilet bowls and tanks. All of your sinks, showers and tub drains should also be sealed. A dry drain or toilet bowl provides easy access for pests. Preferably you should contract someone to check your place on a regular basis.

Declaration Amendment VOTE

We are in the midst of a vote to update our outdated Declaration. If you haven't already voted, we strongly encourage you to do so. You can vote electronically or via a paper ballot. Many residents have opted to sign up and vote by "EZ-Vote" electronic voting, and are impressed with how easy it is to use. If you have not voted, you can get an OPT-IN form from the office to vote electronically, OR you can get a paper ballot from the office, if you haven't already received one. There are a team of volunteers canvassing residents who have not voted to encourage them to voice their opinion. This is a VERY important vote for GHC.

Click "**sign up**" - if this is your first time.

LAST: Enter the **email address you included on your form** and create your own password. Your Request will be verified against your completed / signed form on file. Now you will be approved to access the **Owners Only** private section of our website.

SPECTRUM BULK TV SERVICE!!

As a Resident of Gulf Harbors Condos, you are entitled to one free **TV Box**, to watch your television. A TV Box is required for each TV, to receive Spectrum TV Channels.

Call Spectrum at 1-855-222-0102 – ASK for their Bulk TV Team. Give the representative your GHC civic address as our GHC addresses have been entered into their system to identify you as part of the Bulk TV Service program.

With Our **Bulk TV service** with the TV Box you are entitled to Spectrum Packages of: Spectrum TV Basic, TV Select and TV Bronze. (TV Bronze is Spectrum Digital Tier 1. It is the Silver package listed on their website, without the Movie channels). Additional TV boxes are an additional cost to you as well as other additional channels, movie channels etc. Your *Internet and Phone rates may* change at any time. Exception is our Bulk TV rate on Contract.

Note: If you are advised that your address is not entered in their bulk TV system, please call our GHC office and advise Cindy. The office will contact Spectrum to ensure the address is then added.





As a follow up to my CAM's Corner message in March, we are asking that all residents familiarize themselves with our Rules and Regulations. For the overall benefit of everyone, our CPO staff will be reminding people about infractions. Some common infractions are; improper parking, parking without registration decals, obtaining parking pass for guests, unsuitable clothing going to/from the pool areas, and walking dogs along the channel. We ask that you read and follow our rules and regulations for the respect of your friends and neighbors. It is the responsibility of all owners to ensure that tenants receive a copy of our rules and regulations.

MAINTENANCE CORNER

The Manhole System at Gulf Harbors Condos has never been cleaned. This is causing issues for our sewer systems. The Board of Directors has approved a project to begin cleaning them in a phased approach. Prior to this project, we will be installing back water valves to minimize bugs and rodents from entering condos.

We have determined the first part of the project as Phase 1: which is all of Jasper Dr. through to the end of Jasper out to Marine Parkway for a cleaning and flushing process, to begin the first week of April. If you are leaving for the summer season, we are asking all owners to be prepared by closing the drains on ALL SINKS,

TUB/SHOWER DRAINS - using stoppers or placing a plastic lid with a heavy object on top to ensure no sewer gases, bugs etc. enter your condo.

Toilets should also be made ready. Ensure the toilet tank has water in it. Toilet bowls also NEED water and add BLEACH to the Bowl (not the TANK). If you are leaving your condo for an extended period of time, ensure both the TANK & BOWL have plastic wrap over them to keep the water from evaporating. DRY TOILETS allow bugs and rats to enter your home. This is an ongoing issue at GHC.

If you are not able to ready your unit for this work effort, please contact someone local who can complete these steps for you. It is VERY IMPORTANT to make sure your condo is prepared before we start this project.

Message from the Community Patrol Security Committee

When you are traveling this summer season, please drive safely!

BE SURE to weatherproof your condo for the Hurricane Season. If you have questions, please pick up a copy of the GHC Hurricane Preparedness document from the office. If you are going away REMOVE ALL Outside furniture, flower pots, etc. so your personal items

Do not become projectiles in the WIND!
