Monday, December 14, 2015

The regular monthly meeting of the Town Council of the Corporation of the Town of Rainy River was held on Monday, December 14, 2015 at 7:00 p.m. in the Municipal Council Chambers.

Rainy River District School Board

The School Board representatives presented a PowerPoint report detailing the declining school enrollment and school age population with forecasts for future enrollments. It was noted that they had already done some facility consultations and are working to make school facilities viable for the future.

The School Board has passed a resolution at their November meeting to look at consolidating the Rainy River High School and Riverview Elementary School. There is also an opportunity for partnerships with other organizations such as the library, recreation centre and others. There is

also potential for sale of the existing high school building. The School Board is requesting a letter from the Town of Rainy River indicating interest in exploring partnership opportunities such as a community hub and what they are looking for in this possible collaboration.

It was noted that a new school is being considered for grades K-12 with construction starting in three to five years. The School board representatives were thanked for their attendance and left the meeting at 7:30 p.m. Council noted that the Northwestern Health Unit might be a good fit for this partnership as well.
