Health and Safety Policy

Craze Kidz Club recognises the requirement to conduct its business in such a way as to ensure so far as is reasonably practicable that:

1. Leaders, club members and guests and other people who may be affected by their operations and activities are not exposed to risk to their health and safety.
2. Young people participating in activities organised by the Club are not exposed to unnecessary risks to their health and safety.
3. Members of the public and visitors or persons providing services to the club are not exposed to unnecessary risks.

The overall responsibility for health and safety management on Club Nights is vested with the Co-ordinator. He/she will be supported by a named management committee member appointed by the management committee.

Craze Kidz Club expects its leaders to:

1. To conduct their activities to the standard of any health and safety policies, procedures and risk assessments issued by the club.
2. When working away from the club premises in their capacity as a Club leader act in a manner that meets the requirements of the Club's policies, procedures and risk assessments.

Craze Kidz Club believes that procedures for health and safety and providing quality service go together and reaffirms that safety is a major consideration in all aspects of its activities. To achieve this aim the Club will:

1. Ensure all new leaders are briefed on the Clubs, Health and Safety policies, procedures and risk assessments.
2. Provide sufficient information to keep all leaders up to date regarding any new equipment installed.
3. Ensure, in respect of indoor/outdoor activities organised by the club, that appropriate activities and events are risk assessed so that as far as is reasonably practicable to minimise risk.
