

Prevailing Wage Ordinance
Collinsville Township & Road & Bridge

Whereas, the State of Illinois has enacted "an act regulating wages of laborers, mechanics and other workers employed in any public works by the state, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 2018, as amended Illinois compiled statutes, (820 ilcs 130/1 et.seq.) as amended and

Whereas, the aforesaid act requires that the Road & Bridge department of the Collinsville Township investigate and ascertain the prevailing rate of wages as defined in said act for laborers, mechanics and other workers in the locality of said Collinsville Township employed in performing construction of public works, for said road & bridge department.

Now therefore, be it ordained by Terry "Bones" Allan, Supervisor and Board of Trustees and Larry Trucano, Highway Commissioner of the Collinsville Township.

Section 1: To the extent and as required by "an act regulating wages of laborers, mechanics and other workers employed in any public works by state, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, the general prevailing wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Collinsville Township Road & Bridge is hereby ascertained to be the same as the prevailing rate of wages for construction work in Madison County area as determined by the Department of Labor of the State of Illinois as of June of the current year a copy of that determination being attached hereto and incorporated herein by reference. as required by said act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall superseded the department's June determination and apply to any and all public works construction undertaken by the Collinsville Township Road & Bridge. The definition of any terms appearing in this ordinance which are also used in aforesaid act shall be the same as in said act.

Section 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of the Collinsville Township Road & Bridge to the extent required by the aforesaid act.

Section 3: The Collinsville Township Clerk shall publicly post or keep available for inspection by any interested party in the main office of the Collinsville Township this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

Section 4: The Collinsville Township Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employers who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.


Section 5: The Collinsville Township Clerk shall promptly file a certified copy of this ordinance with the Illinois department of labor.




