**Backcountry Film  
Festival and Glade  
Project Update**

Superior Highland Backcountry (SHB), a north-shore based non-profit whose mission is to preserve and expand backcountry ski opportunities along the North Shore, is hosting the Backcountry Film Festival once again. This time though, the film premieres with their very own film, created by Josef Fairbanks of Duluth. At just over six minutes, the film describes the potential expansion of Lutsen Mountain Resort onto the public acreage of Moose Mountain, and SHB's alternative proposal for a backcountry or sidecountry ski area. Artistic and scenic, the film includes a spokesperson for the Grand Portage band, and ends with sweet footage of powder turns on Moose. Film screenings are all virtual this year due to Covid-19. Tickets can be purchased through the website [www.superiorhighlandbc.org](http://www.superiorhighlandbc.org), and proceeds benefit the efforts of SHB.

Lutsen Mountain Resort has submitted an application for a Special Use Permit to the Superior National Forest. It is currently in the environmental review process, with the draft Environmental Impact Statement to be released soon. There will be a public comment period open following the release of the EIS. The next project SHB is taking on is a Finland Glades backcountry ski area. The application for a conditional use permit has been accepted by Lake County, and a public hearing is scheduled for December 21st.
