CITY OF WEBSTER AMENDED EMPLOYMENT AGREEMENT FOR CITY MANAGER

THIS AGREEMENT is made and entered into this _____ Day of _____,2024, by and between the City of Webster, a municipal corporation of the State of Florida, hereinafter called "CITY", whose address is 85 E. Central Avenue, Webster, Florida 33597 and Deanna Naugler, whose address is 29084 Wildlife Lane, Brooksville, FL 34602, hereinafter called "MANAGER".

WITNESSETH:

WHEREAS, the CITY desires to employ the services of said MANAGER as the City Manager of the City of Webster, as provided by Florida law and the City Charter of the City of Webster ("City Charter"); and

WHEREAS, the MANAGER represents that <u>(he or she)</u> is capable of serving and desires to accept employment as City Manager of the City of Webster; and

WHEREAS, it is the desire of the City Council of the City of Webster to engage the MANAGER and provide certain benefits and establish certain conditions of employment to which the MANAGER has agreed.

NOW, THEREFORE, in consideration of the premises and other mutual promises and covenants herein contained, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

SECTION 1. RECITALS.

The above recitals are true and correct and constitute a part of this Agreement upon which the parties have relied.

SECTION 2. DUTIES.

The CITY hereby agrees to employ the MANAGER as the City Manager of the City of Webster to perform the functions and duties specified in the City Charter, the City Code of the City of Webster, applicable Florida law and sound and generally accepted practices relating to public administration as well as to perform all other legally permissible and proper duties and functions as the City Council of the City of Webster may from time-to-time assign to the MANAGER. The MANAGER commenced full-time employment on April 22, 2016. The MANAGER agrees to fully and faithfully execute the duties and responsibilities of the office of City Manager of the City of Webster under any and all applicable law.

SECTION 3. GENERAL TERMS AND CONDITIONS OF EMPLOYMENT

(a) Nothing in this Agreement shall prevent, limit or otherwise interfere with the right of the City to terminate the services of MANAGER at any time, subject only to the provisions set forth in Section 10(a) of this Agreement.

(b) Nothing in this Agreement shall prevent, limit, or otherwise interfere with the right of the MANAGER to resign at any time from (his or her) position with the CITY, subject only to the provisions set forth in Section 10(b), I 0(c) and 10(d) of this Agreement.

(c) The MANAGER agrees to remain in the exclusive employment of the CITY and not be employed by any other employer unless otherwise mutually agreed by both parties. For purposes of this Subsection, however, employment shall not mean occasional teaching, presentations to professional organizations and professional consultation on the MANAGER's time off and to the extent such does not conflict or interfere with MANAGER's duties hereunder and is in the best interests of the CITY.

(d) IN the event that the MANAGER applies for other employment while employed by the CITY, the MANAGER shall disclose such efforts to the CITY in writing. Failure to do so shall be a breach of this AGREEMENT by MANAGER.

SECTION 4. COMPENSATION.

The CITY agrees to pay the MANAGER for <u>(his or her)</u> services rendered pursuant to the terms and conditions of this Agreement. The City Manager shall be paid in equal payments at the same time other City employees are paid. The MANAGER's salary shall be reviewed annually by the City Commission of the City of Webster during the succeeding month after each twelve (12) month period that this Agreement is in effect. The CITY agrees to consider an increase in the MANAGER's salary and other benefits payable to the MANAGER in such amounts as offered to city employees through the annual performance appraisal process or higher to such extent as the CITY may determine desirable based on the City Commission's collective written evaluation of the MANAGER's performance during the evaluation period.

SECTIO 5. PERFORMANCE EVALUATION.

(a) The CITY shall review and evaluate the performance of the MANAGER at least once annually. Said review and evaluation shall be in accordance with specific criteria developed jointly by the City Council and the MANAGER. Said criteria may be added to or deleted from as the City Council may from time-to-time determine, in consultation with the MANAGER. Further, the City's HR Manager shall provide the MANAGER with a written summary statement of the findings of the City Council and provide an adequate opportunity for the MANAGER to discuss (his or her) evaluation with the City Council in a manner consistent with State law as guided by the City Attorney.

(b) Annually, the City Council and the MANAGER shall define such goals and performance objectives which they determine necessary for the proper operation of the City's Government and the attainment of the City Council's policy objectives and shall further establish a relative priority among those various goals and objectives. Said goals and objectives shall be reduced to writing in an appropriate forum. They shall generally be attainable within the time limitations as specified and the annual operating and capital budgets and appropriations provided.

SECTION 6. AUTOMOBILE AND CELL PHONE.

(a) The CITY shall provide the MANAGER with an automobile for his or her use which automobile shall be owned and maintained by the CITY as part of its fleet of motor vehicles or, in lieu of the use of a CITY-owned vehicle, the MANAGER shall maintain his or her own personal vehicle for his or her duties as City Manager of the City of Webster. In the event the MANAGER elects to maintain his or her own personal vehicle, the CITY shall pay the MANAGER the sum of THREE HUNDRED DOLLARS (\$350.00) per month as an automobile allowance to reimburse the MANAGER for his or her automobile expenses. The MANAGER shall be responsible for paying all premiums due for liability, property damage and comprehensive insurance and for the purchase, operation, maintenance, repair and regular replacement of their own automobile if used.

(b) The CITY shall provide a cellular phone for the MANAGER to use for CITY business which shall be and remain CITY property in the event that the MANAGER vacates the position of City Manager of the City of Webster for any reason. Any and all charges for non-city business cellular phone calls, if any, will be the responsibility of the MANAGER.

SECTIO 7. INSURANCE COVERAGE.

The CITY shall provide to the MANAGER the same coverage and benefit package and plan available to all other CITY employees in the CITY's Group Health Insurance Program, or provide compensation in an amount equal to that coverage as direct payment, if MANAGER chooses to obtain health insurance outside of the CITY'S provider.

SECTION 8. LEAVES AND HOLIDAYS.

(a) It is recognized that the MANAGER's work hours will vary from day to day and that (his or her) office hours will be at various times based upon the needs of the CITY. It is also recognized that the MANAGER is on-call twenty-four (24) hours a day and seven (7) days a week and maintains, at all times, the plenary obligation to administer City Government in accordance with the provisions of the City Charter, State law and sound and generally accepted public management and local government administration practices and principles. (b) The MANAGER shall ensure that the Mayor is promptly apprised on each and every occasion during which (he or she) will not be available to accomplish (his or her) day-to-day activities as MANAGER due to leave or other authorized absence (in advance if practicable) and that a CITY employee (of suitable position and stature) is appointed to act in the MANAGER's place and stead during such absence. The Mayor shall be advised of the person so appointed.

(c) On the date this AGREEMENT becomes effective, and at the beginning of each new contract year thereafter, MANAGER shall be credited with an additional vacation leave credit of sixty-four (64) hours in addition to his or her currently earned vacation leave hours. The MANAGER shall also accrue additional vacation leave at the rate of a regular employee pursuant to the CITY Personnel Policy.

(d) The MANAGER shall be entitled to holidays as any other CITY employee.

(e) The MANAGER shall be entitled to be eavement leave under the same terms and conditions as any other CITY employee.

SECTION 9. INDEMNIFICATION AND BONDING.

(a) The CITY shall defend, save harmless and indemnify the MANAGER against any tort, professional liability claim or demand or other legal claim or action, whether groundless or otherwise, arising out of an alleged act or omission occurring in or arising out of the good faith performance of the MANAGER's duties as City Manager of the City of Webster. However, this covenant shall not apply to acts outside the scope of MANAGER's employment or services or for claims for punitive damages. The CITY will have the authority to compromise and settle any such claim or suit within the scope of MANAGER's employment and pay the amount of any settlement or judgment rendered thereon.

(b) To the maximum extent permitted by law, the CITY and the MANAGER shall rely upon the doctrine of sovereign immunity and the provisions of Section 768.28, *Florida Statutes*, and other applicable law.

SECTION 10. TERMINATION AND SEVERANCE PAY.

(a) Any termination of the MANAGER shall be accomplished in accordance with the provisions of the City Charter and requires a unanimous vote of all 5 council seats. In the event that the MANAGER is terminated by the CITY for any reason other than termination based upon a finding of violation of Chapter 112, Part 3, *Florida Statutes;* violation of the City Charter; or for any action that would constitute an abandonment of office, a departure from generally accepted public management practices and principles, or malfeasance or misfeasance in office, while the MANAGER is willing and able to perform the duties of City Manager of the City of Webster, then and in that event the CITY agrees to pay the MANAGER a lump sum severance pay equal to twelve (12) months of the MANAGER 's then current salary (this includes health insurance and retirement contributions) together with accrued vacation and sick leave under the same terms and conditions as any other City employee; provided, however, that in the event that the MANAGER is terminated

based upon a finding of violation of Chapter 112, Part 3, *Florida Statutes;* violation of the City Charter; or for any action that would constitute an abandonment of office, a departure from generally accepted public management practices and principles, or malfeasance or misfeasance in office then, and in that event, the CITY shall have no obligation to make severance payment provided for in this Section.

(b) In the event the CITY, at any time during the employment, reduces the financial benefits of the MANAGER in a greater percentage than any applicable across-the-board reduction for all CITY employees, or in the event that the CITY refuses, following written notice, to comply with any other provision of this Agreement, the MANAGER may be deemed to be "terminated without cause" within the meaning of Section IO(a) at the date of such reduction or such refusal to comply with the provision of this Agreement.

(c) In the event the CITY, at any time during the employment of the MANAGER, refuses, following written notice, to comply with any of the terms of this Agreement benefiting the MANAGER, or the MANAGER resigns following a corporate suggestion by the City Council of the City of Webster that (he or she) resign, then in that event, the MANAGER may, at his or her option, consider (himself or herself) "terminated without cause" within the meaning of Section 10(a) on the date of such action by the City Commission of the City of Webster and the severance provision shall become applicable.

(d) In the event the MANAGER voluntarily resigns (his or her) position with the CITY, then the MANAGER shall give the CITY no less than thirty (30) days written notice in advance, unless the parties otherwise agree.

SECTION 11. RETIREMENT.

The CITY agrees to pay the Florida State Contribution Rate for the position class of HI/PI "Appointed Position" as part of (his or her) annual salary toward retirement contributions for employee. This payment will be divided equally across each bi-weekly payroll.

SECTION 12. PROFESSIONAL ASSOCIATIONS AND DEVELOPMENT.

(a) The CITY agrees to pay for the reasonable professional dues and subscriptions of MANAGER as may be necessary for (his or her) continuation and participation in the International City County Management Association and the Florida City and County Management Association.

(b) The CITY hereby agrees to pay the reasonable travel and subsistence expenses of MANAGER for professional and official travel, meetings and occasions adequate to reasonably continue the professional development of the MANAGER and to adequately pursue necessary official and other functions for the CITY including, but not limited to, the International City/County Management Association, the Florida City, County Management Association annual meetings, and meeting of the Florida League of Cities. (c) The CITY hereby agrees to consider in each year's budget and to pay for the reasonable travel and subsistence expenses of the MANAGER for short courses, institutes and seminars that are necessary for (his or her) professional development and for the good of the CITY as such sums may be budgeted.

(d) The MANAGER agrees that within twenty-four (24) months of employment as City Manager by the CITY to pursue becoming a Certified Public Manager.

(e) The CITY recognizes that from time-to-time, certain expenses of a nonpersonal and generally job affiliated nature may be incurred by the MANAGER in (his or her) capacity as City Manager of the City of Webster, which amounts shall be reasonably reimbursed or paid to the MANAGER in amounts in not to exceed appropriations for the same and in accordance with CITY policies.

SECTION 13. OTHER TERMS AND CONDITIONS OF EMPLOYMENT.

The CITY shall fix any such other terms and conditions of employment, as it may determine from time-to-time, relating to the performance of the MANAGER; provided, however, that such terms and conditions are not inconsistent with or conflict with the provisions of this Agreement, the City Charter, CITY policies and procedures, State law or any other applicable law. These changes will require a unanimous vote of all 5 council seats in order to be implemented.

SECTION 14. NOTICES.

(a) Postal Service, postage prepaid, addressed as follows:

(b) Alternatively, notice required pursuant to this Agreement may be personally served in the same manner as is applicable to civil judicial practice. Notice shall be deemed given as of the date of personal service or as the date of deposit of such written notice in the course of transmission in the United States Postal Service.

SECTION 15. GENERAL PROVISIONS.

(a) The language of the City Charter relating to the position and functions of the City Manager of the City of Webster is incorporated herein by reference into this Agreement as though it were set forth in the text of this Agreement verbatim.

(b) If any provision, or any portion thereof contained in this Agreement is held to be unconstitutional, invalid or unenforceable, the remainder of this Agreement, or portion thereof, shall be deemed severable, shall not be affected and shall remain in full force and effect.

(c) Time is of the essence of the lawful performance of the duties and obligations contained in this Agreement. The parties covenant and agree that they shall diligently and expeditiously pursue their respective obligations set forth in this Agreement.

(d) This Agreement and the terms and conditions hereof shall be binding upon and inure to the benefit of the CITY and the MANAGER and their respective successors in interest.

(e) This Agreement and the provisions contained herein shall be construed, controlled and interpreted according to the laws of the State of Florida. Florida law shall govern the interpretation and enforcement of this Agreement. Further, venue for any dispute resulting from this Agreement shall be in the Eighteenth Judicial Circuit Court in and for Seminole County, Florida.

(f) Each party hereto represents to the other that it has undertaken all necessary actions to execute this Agreement, and that it has the legal authority to enter into this Agreement and to undertake all obligations imposed on it.

(g) This Agreement is the result of bona fide arms length negotiations between the parties and both parties have contributed substantially and materially to the preparation of the Agreement. Accordingly, this Agreement shall not be construed or interpreted more strictly against any one (1) party than against any other party.

(h) In the event of any action to enforce the terms of this Agreement, the prevailing party shall be entitled to recover reasonable attorneys' fees, paralegals' fees, and costs incurred, whether the same be incurred in pre-litigation negotiation, litigation at the trial level, or upon appeal.

(i) The headings or captions of the sections and subsections contained in this Agreement are used for convenience and reference only and do not, in themselves, have any legal significance and shall not be afforded any.

(j) The parties shall comply with applicable State and local laws, regulations and ordinances. All laws relating to the open government, public meetings and public records shall be carefully complied with.

(k) This Agreement may not be amended, changed, or modified, and material provisions hereunder may not be waived, except by a written document, of equal dignity herewith and signed by all parties to this Agreement.

(1) This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which, taken together, shall constitute one and the same document.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be duly executed by affixing their signature thereto on the dates indicated.




 \cdot Addressed issues with too much air in the city water system. Contacted U.S. Water to correct the issue. Too much air was added to the hydro tank at the North Well.

When Was the First Earth Day?

The first Earth Day took place on April 22, 1970.

On June 22, 1969, the Cuyahoga River on the southern shores of Lake Erie caught on fire as chemicals, oil, and other industrial materials that had oozed into the river somehow ignited. Just a few months before, on January 28, 1969, an oil rig leaked millions of gallons of oil off the coast of Santa Barbara. That same year, reports surfaced that our national symbol, the bald eagle, was rapidly declining as a species due to the chemical DDT, while around the world, whales were being hunted nearly to extinction. These and other incidents caught the attention of the national media and galvanized public awareness of the many environmental insults being hurled at the nation and the planet.


In response to the public outcry, Earth Day Founder Gaylord Nelson, who served as the Governor of Wisconsin (1958-1962) and in the U.S. Senate (1963-1981), organized a nationwide "teach-in" about environmental issues to take place on April 22, 1970. More than 2,000 colleges and universities, 10,000 public schools, and 20 million citizens participated—nearly 10 percent of the U.S. population at that time. This outpouring of grassroots environmental activism marked the first Earth Day—a recognition of the importance of caring for the environment and accepting stewardship responsibility for the nation's resources. It also helped establish a political climate conducive to forming both the National Oceanic and Atmospheric Administration (NOAA) and the U.S. Environmental Protection Agency (EPA) on October 3, 1970.

We like to say that "Every day is Earth Day at NOAA." But ever since April 22, 1970, people the world over take time to recognize the importance of protecting the Earth's natural resources—be they oceanic, atmospheric, terrestrial, or biological—for future generations.

ORDINANCE NO. 2024-11

AN ORDINANCE OF THE CITY OF WEBSTER, FLORIDA PROVIDING FOR THE REZONING OF REAL PROPERTY TOTALING 10.07 ACRES, MORE OR LESS, IN SIZE (TAX PARCEL IDENTIFICATION NUMBER T07D002) WITHIN THE CITY LIMITS (MAP OF PROPERTY ATTACHED) TO RR1C, RURAL RESIDENTIAL WITH CONVENTIONAL HOUSING ZONING DISTRICT FROM A10C (COUNTY); PROVIDING FOR THE TAKING OF IMPLEMENTING ADMINISTRATIVE ACTIONS; PROVIDING FOR THE ADOPTION OF A MAP BY REFERENCE; REPEALING ALL CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING FOR NON-CODIFICATION AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, , Loretta Ramirez mailing address: 11305 CR-723, Webster FL

33597 is the owner of the property which is the subject of this Ordinance; and

WHEREAS, The real property, totaling 10 +/- acres in size, is located on the South and East of CR 758 and 723 respectively; and

WHEREAS, Loretta Ramirez owned the subject property, in November 2023 when

a voluntary annexation into the municipal limits of the City of Webster, Florida.; and

WHEREAS, The City Manager of the City of Webster pursuant to the controlling provisions of State law and the Code of Ordinances of the City of Webster, is petitioning to have the subject property reassigned from the A10C (Agriculture -County) zoning assignment to the RR1C (Rural Residential with Conventional Housing) zoning assignment;

WHEREAS, the City Council of the City of Webster, Florida has taken, as implemented by City staff, all actions relating to the approval action set forth herein in accordance with the requirements and procedures mandated by State law.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF WEBSTER, FLORIDA:

SECTION 1. LEGISLATIVE FINDINGS AND INTENT.

(a). The City Council of the City of Webster hereby adopts and incorporates into this Ordinance the City staff report as well as the recitals (whereas clauses) to this Ordinance.

(b). The subject property, which is a 10.07 acre MOL platted lot, and is located adjacent to CR-723, a minor local road. (Tax Parcel Number T07D002). The legal description of the subject property is provided in Attachment A.

(c). The City of Webster has complied with all requirements and procedures of Florida law in processing and advertising this Ordinance.

SECTION 2. REZONING OF REAL PROPERTY/IMPLEMENTING ACTIONS.

(a). Upon enactment of this Ordinance the following described property, as depicted in Attachment A of this Ordinance, and totaling is 10.07 acres MOL in size, shall be rezoned from A10C(County) zoning districts/classification to RR1C zoning district/classification.

(b). The City Manager, or designee, is hereby authorized to execute any and all documents necessary to formalize approval of the rezoning action taken herein and to revise and amend the Official Zoning Map or Maps of the City of Webster as may be appropriate to accomplish the action taken in this Ordinance.

SECTION 3. INCORPORATION OF MAP. The map attached to this Ordinance as the Attachment is hereby ratified and affirmed and incorporated into this Ordinance as a substantive part of this Ordinance.

SECTION 4. CONFLICTS. All ordinances or part of ordinances in conflict with this Ordinance are hereby repealed.

SECTION 5. SEVERABILITY. If any section, sentence, phrase, word, or portion of this Ordinance is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Ordinance not otherwise determined to be invalid, unlawful, or unconstitutional.

SECTION 6. NON-CODIFICATION. This Ordinance shall not be codified in the *City Code of the City of Webster* or the *Land Development Code of the City of Webster*; provided, however, that the actions taken herein shall be depicted on the zoning maps of the City of Webster by the City Manager, or designee.

SECTION 7. EFFECTIVE DATE This Ordinance shall take effect immediately upon enactment provided, however, that the rezoning of property herein set forth shall not take effect until Ordinance Number 2024-10 relating to the Comprehensive Amendment becomes effective.

SURROUNDING LAND USE AND ZONING

The subject property is located adjacent to CR-723, a minor local road. It is currently is vacant land, surrounded by vacant lands, single family homes and an agricultural research and development facility. The property was annexed into the City in November 2023. Surrounding zoning assignments include Residential with varying densities (RR5C, RR1, R2M and RR1C) (Map 2). The neighborhood is residential agricultural in nature.

CASE SUMMARY

The rezoning will add the property to the City's Zoning Map with a RR1C (Rural Residential with Conventional Housing) zoning designation. The RR1C zoning assignment will allow for one (1) conventionally built home along with a variety of typical residential accessory uses.

CASE ANALYSIS:

The request is to adopt City zoning following annexation. This application is concurrent with a small scale Land Use Amendment SS-23-19550 which seeks a Rural Residential Land Use assignment

LDC Section 13-313 (d), *General Administration of Amendment and Permit Applications-Review and Approval Process*, provides for the following review criteria for LDC and zoning map amendments:

- a) Change of conditions, or absence of changed conditions. The property has been annexed into Webster and needs to be adopted onto the City zoning map.
- b) Community need, or lack of community need. *The requested rezoning will allow additional rural residential development in the rural residential area.*
- c) Benefits to the community. The rezoning will benefit the community by allowing residential development in keeping with the pattern of the neighborhood.
- d) The rights of private property owners. *This rezoning should preserve the existing rights currently in place with County Land Use and Zoning.*

HEARINGS

The Application is expected to be heard by Planning and Zoning Board on February 8, 2024; and,

City Council on February 15th and March 21, 2024.

CONCLUSIONS

Staff deemed the application sufficient for review. Staff has found the request in compliance with the minimum requirements of the Webster Land Development Code and Comprehensive Plan and recommends approval contingent upon approval of Future Land Use Amendment SS-23-19550.
