

3/25/2019

Sgt. Galloway handled a walk-in, in reference to a protection order.

Sgt. Peska responded to a structure fire on Headley Ridge Road. Several Fire Departments from local agency responded. Upon arriving on scene and speaking with several witnesses, the fire is still under investigation and the State Fire Marshall was notified.

Sgt. Peska and Deputy Weekley responded to a stolen vehicle. The case/investigation is pending.
