

Blue Water Vietnam Veterans & Agent Orange Exposure

United States Court of Appeals for the Federal Circuit

ALFRED PROCOPIO, JR., Claimant-Appellant

#### 2017-1821

The court ruled on January 29, 2019, 9 to 2 that service in Vietnam included the 12-naticual mile limit in the waters of the coast of Vietnam. So, if you served in any of the waters close to Vietnam with in the 12naticual mile limit it is in your best interest to file for Veteran benefits.

### MAKING WAVES

Ask President to Help AOBWN Veterans!

The FRA has signed onto a letter to President Donald Trump with other Veteran Service Organizations (VSO) requesting that he direct Department of Justice NOT to appeal the U.S. Appeals Court for the Federal Circuit decision in Procopio v. Wilkie, decided on January 29, 2019. This decision recognizes that Blue Water Navy veterans have been exposed to the Agent Orange herbicide and makes them eligible for VA benefits.

The letter urges the president to direct the Secretary of Veterans Affairs to immediately begin implementing this decision so that justice is finally provided to these veterans who served in Vietnam, suffered from the devastating long-term health effects of Agent Orange exposure, but who today are denied the benefits and health care they have earned. Members are urged to use the <u>Action Center</u> to ask President Trump to help these veterans.
