1. Complete entire application form along with submitting a \$10.00 application fee.
2. Submit an official high school transcript and/or GED Scores and transcripts of previous post-secondary education. An Official transcript is one that is received directly from an issuing institution. (You may deliver it to NTI only if it remains in the institutional envelope.)
3. Submit ACT, COMPASS or Accuplacer test scores (taken within the last three (3) years). The Accuplacer exam may be taken Monday through Friday from 7:30 a.m. until 12 p.m. in the NTI Testing Center. There is a \$10.00 fee. The Accuplacer exam can also be taken multiple testing sites throughout Northwest Arkansas. Please check with your local college or high school for testing information. Below are the tests and minimum scores required for general admission.
