#### IX NEW BUSINESS

#### A DISCUSSION WITH SEAGO DIRECTOR EXECUTIVE, RANDY HEISS

Mr. Heiss opened with a very favorable comment concerning the environment of the Center especially the difference in the mood of the clients comparing the previous environment in the spring as hostile and confrontive to now as being comfortable and trustworthy. Also the food was very good, the service was good and the building was clean with the activity room being newly painted. Mr. Heiss congratulated the Board for their effort and their volunteer work. He stated that the service plan was current and compliant. The Center was current on all insurance requirements.

Mr. Heiss explained that SEAGO has gone through federal cuts as well as some grants have been reduced. In the beginning of the year SEAGO will reevaluate if the Centers are actually producing the

service that their plan indicated. In some areas there may be less activity and the dollars not spent can be diverted to other centers. It was pointed out to Mr. Heiss by Mrs. Zeinun of the difficulty of trying to plan or even to do a budget with no guarantee of a specific amount of money to work with. One of his recommendations was that we maybe could market and cater the center's food service in the community to increase our income. Also there seems to be some delivery issues with Fed Ex and the possibility of the Center again delivering meals to the home bound clients in Santa Cruz County will be discussed in the near future.

This discussion included the donation of a television by the Nogales Police Department and the preparation to install it. Also the telephones, fax and the computer hook-up contract was re-negotiated with Century Link for \$118.00 a month. Dr. Montiel informed Mr. Heiss that paint donated by the City is sufficient to point the entire inside building and will be done according to an estimate of \$250.00.

#### F CLOSURE OF CENTER OVER CHISTMAS

There has been an ongoing discussion at the Center if it would be a hardship to the clients if the Center was closed over the Holidays. This has been accepted without any comments. Dr. Montiel is going to do a survey where the clients can comment on paper if they have any problem with the closure and this will be private and confidential. The discussion ended in a motion of closing the center on December 22, 2014, and opening on January 4, 2015.
