ORDINANCE NO. 15-07

AN ORDINANCE RATIFYING AND CONFIRMING THE VACATION OF A CERTAIN ALLEY IN BOOS' ADDITION TO THE CITY OF NEWTON, JASPER COUNTY, ILLINOIS

BE IT ORDAINED by the City Council of the City of Newton, Jasper County,
Illinois, that it has been determined that the public interest would be served by vacating
the following alley located in the City of Newton, Jasper County, Illinois, legally
described as follows, to-wit:

The Twelve (12) foot wide alley running East and West between the Lots 5 and Lot 9 in Block 7 of Boos' Addition to the City of Newton.

Which said alley is hereby vacated and this vacation of alley shall be deemed effective as of September 3, 2013 in that it was the intent of the City Council to vacate the above described alley by Ordinance No. 13-9, however the wrong legal description was inadvertently included in said Ordinance;

Provided, that the City of Newton, Jasper County, Illinois, does hereby reserve and retain the right to place, use, maintain, operate, repair and replace, by itself or by any licensee, or a holder of a franchise from the City, poles, wires, pipes, conduits, sewer mains, water mains, and/or any other facility or equipment for the maintenance or operation of any utility now located or hereafter placed on any part of the alley vacated by this Ordinance.

BE IT FURTHER ORDAINED that the City Clerk shall record in the Office of the Recorder of Jasper County, Illinois, a duly certified copy of this Ordinance.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
