 music. Music must not be longer than 45 seconds. Posing music must be the only music on the CD and
 music will be collected at <u>Check-ins on Friday night</u>. All Bodybuilding, Classic Physique, and Women's
 Physique will not use music at prejudging.
- Crossovers will be permitted in EVERY division.
