- 4. Scott brought up the subject of some ED Techs wanting to work in the hospital and are AEMT or Paramedic certified, however they are not affiliated with an EMS service. How can these people be a tech without being an affiliate? Would they have to develop a Fast Squad within the hospital? He and Jes are asking as introductory questions for now and what are the challenges and barriers involved. Chris talked about the current ED Tech staff can cause a shortage of EMS personnel in the field on any given day, etc. He also recommended contacting the State EMS office to find out what their stance would be.
