Holiday Reminders: As you get ready to make your home sparkle like Las Vegas for the holiday season, please be mindful not to shine lights at your neighbor's windows, and also please be aware that Christmas decorations may only be displayed after Thanksgiving, and must be taken down one week after the holiday (typically New Year's Day). For all other holidays throughout the year, decorations must be removed within one week after the holiday passes.

We were fortunate to have mild weather going into the 2014 holiday season, so residents displayed an abundant spectacle of lights, showcasing their holiday spirit with creativity and imagination. We'd like to thank everyone who decorated for the holidays, and we are grateful that all of you have chosen Sugar Mill as your community.

Modifications Require Permits: Projects that involve altering, repairing, constructing, or moving a structure require a City of Sugar Land permit. It is the responsibility of the property owner to obtain the proper permits before construction begins. Please contact the Permits and Inspections Department at 281-275-2270 for more information. Please remember that all modifications (including



painting) to the exterior of your home or property must also have Sugar Mill Architectural Control Committee approval, prior to beginning.

Junked Vehicles: A junk vehicle is defined as one that has an expired license plate or inspection sticker, AND is wrecked, dismantled, or discarded, or is inoperable for more than 72 hours, if the vehicle is on public property; or 30 consecutive days, if the vehicle is on private property. Please report all junked vehicles to the City online at http://www.sugarlandtx.gov/index.aspx?NID=1298, and/or contact Terri Salter, Sugar Mill's property manager (contact info on cover page of this newsletter).

Boat Ramp: If you do not live on the lake, but have a small boat (under 14 feet in length) that has an electric motor, or a canoe or kayak that is under 17 feet in length that is human-powered, the only boat ramp within Sugar Mill, is located on Lakeway, off of Spinnaker Way.


Great Way to Stay In Touch: I recently learned about a nifty website called **Nextdoor.com**. There are currently about 200 Sugar Mill residents who have joined (it's free), and when someone needs a plumber recommendation, people within Sugar Mill respond. When someone lost their dog, the people who found it responded. If you have something to sell, you can post it in their classified section. Again, this is free of charge, but can be a powerful tool since you can specifically target just Sugar Mill residents, or you can target neighboring subdivisions as well. We encourage everyone to join!

Tree Trimming: Property owners are required to trim trees in accordance with the following guidelines:

• Where the tree overhangs a residential street, there must be a clear space under the tree that is 12 feet above the street surface.

• Where the tree overhangs a residential sidewalk, there must be a clear space under the tree that is 8 feet above the sidewalk surface.

• Where the tree overhangs our Sugar Mill lake, there must be a clear space under the tree that is 7 feet above the bulkhead so that a boat with a standard canopy may travel under the tree without the tree hitting its canopy.



Both the City of Sugar Land, as well as the Sugar Mill management team, routinely monitor to ensure trees are in compliance.

Rental Property Owner Requirements: If you own any rental property in Sugar Land, as the property owner, you will have to meet a few requirements under the city's rental program including:

• Annually filing an application for a rental license and paying \$87 licensing fee.

• Submit to a property inspection by the City to ensure that you are maintaining your property in compliance with all city codes relating to health, sanitation, and property maintenance.

• Remedying any violation of city codes found on your property.

• Not renting your unit to a registered sex offender if the unit is within 2500 feet of an area designated as a child area under Article XI, Chapter 3 of the Sugar Land Code of Ordinances.

Owners of unlicensed rental properties can be fined up to \$500 a day for each day that the unit is rented without a license. Water service will also not be provided to rental properties not having a license. For more information, contact the City of Sugar Land Rental Licensing Program at (281) 275-2785. You may also call that number if you wish to report a rental property you suspect may be in violation of this ordinance.

Important Reminders: Tell your kids you love them, eat your vegetables, drive slow through the neighborhood, get out there and exercise (inactivity leads to rust), and whatever you do - don't feed the ducks!!

Marion's Fishing Corner



The Fall Turnover

Autumn is finally here, and summer patterns are quickly fading. With this in mind, I think that it would be

pertinent to revisit a topic that we discussed last fall. It's time for area lakes to "turnover", and here is a brief explanation:

Every year at this time, our area lakes experience a phenomenon known as "fall turnover". What exactly is turnover? Well, in a nutshell, this is what usually happens. As our average daytime and nighttime temperatures go down, the top layer of water in the lake begins to cool. The advent of shorter days and longer nights accelerates the process. With cool water being heavier than warm water, the cool upper layer will eventually "sink" to the bottom of the lake. This in turn forces the warmer bottom layer of water to the surface. As this occurs, it disturbs silt and sediment from the bottom of the lake and normally causes the water clarity to decrease. Also, dissolved oxygen levels

are affected. All of these factors combined will usually disrupt the fish's feeding habits. The combination of unstable oxygen content, murky water, and changing PH levels will usually negatively affect fishing success for a while. Luckily, the affects of the fall turnover only last a short time. Within a few days, the water will usually stabilize and the fish will get back to their normal feeding habits.

Turnover is a normal occurrence that happens to all lakes in our area. It is a shortlived interruption to some otherwise very favorable fishing conditions. So when these conditions exist, just be patient and give the lake a few days to stabilize. The wait should be well worth it.

Remember to always catch and release, because a bass is far too valuable of a resource to catch just once.




