The Arunachal Pradesh State Rural Livelihoods Mission(ArSRLM) is an autonomous society under the Government of Arunachal Pradesh supported by National Mission Management Unit (NMMU) of Ministry of Rural Development Govt. of India (MoRD). The Mission is also Nodal Agency for planning, implementation and monitoring and evaluation of all manner of interventions for implementation of Deen Dayal Antyodaya Yojana National Rural Livelihoods Mission (DAY-NRLM)/Aajeevika and Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU GKY) and other sub schemes under DAY NRLM.

**District Mission Management Unit (DMMU).**

Arunachal State Rural Livelihoods Mission (ArSRLM) has District Mission Management Unit (DMMU) on Cluster basis where one DMMU caters to several nearby districts in a cluster approach. The location of a District Mission Management Unit in any given district does not in any way imply according any preference for coordination and pursual of matters in the concerned district. The District Mission Management Units under ArSRLM are solely for extending the outreach of State Mission Management Unit (SMMU) and providing support to all constituent Block Mission Management Units. As an extended arm of SMMU, the DMMUs shall also be actively involved in monitoring, review of progress and reporting on physical / financial progress of BMMUs. The DMMUs shall also engage in networking with District Administration as well as officials of all concerned line departments of all concerned districts in the given cluster for facilitating access to citizen entitlements, facilitating the demands of PLFs / CLFs to be considered by the Gram Sabhas. DMMUs shall also be instrumental in leveraging platform of institutions of rural poor women by departments such as Health, Women and Child Development, Agriculture, Horticulture, Animal Husbandry and Veterinary, Fisheries, Social Justice, etc. for furthering their work by facilitating outreach.


