MINUTES OF BUDGET WORKSHOP

May 5, 2022 at 6:00PM

APPROVAL OF MINUTES

Mrs. Salka reviewed over each line item with Council on the proposed budget that was presented. She asked Council if there were any line items that need to be raised or lowered. Mrs. Salka stated that she would like to change the layout of the budget starting fiscal year July 2023. Mayor Tony Junious asked about Duckfest and whether the Town handles any part of it. Mrs. Salka responded that Duckfest uses the room out in the bay and uses the barricades. Mayor Tony Junious asked if the Town paid the employees who cleans up after the festival. Mrs. Salka stated that Duckfest pays for that. Mayor Tony Junious also asked if Duckfest paid for the law enforcement personnel as well. It was discussed by several council members of how costs, of a festival that it is/was held by an organization non-town related, were incurred and how should it incur future costs. Mrs. Salka did state that when invoices are coming in that they needed to be coded the right way so that each department is paying for them appropriately. Mrs. Salka said that the Organizational Chart was a draft. It was discussed by Council and asked to be brought back on the May 10th agenda under Administrator Report.
