This is your FINAL confirmation letter for the EGRC AKC Agility Trial Aug 30 - Sept 2, 2019 at Argus Ranch in Auburn, WA. **Trial Information:** Trial statistics and other pertinent information will be posted at [www.k-9sports.com](http://www.k-9sports.com).

**Move-ups:** The deadline to send in your move-up is Monday, Aug 26, 2019 at 6:00 pm. Move-ups must be submitted in writing (email ok).

**Height Cards/Measuring:** We will have a VMO available for measuring. All dogs without height cards will have to be measured, including 24" and 24C" dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a measuring official available to measure dogs each day near the trial secretary's table.

**Start Time & Running Order:** Check in and measuring time will begin at 9:00 am on Friday and 7:00am on Saturday, Sunday and Monday. We will be measuring throughout the day, just make sure your dog is measured prior to your first run. First dog on the line on Friday, Saturday and Sunday will be at 9:00am and Monday will have first dog on the line at 8:00 am. The class running order will be as follows:

**NOTE: ALL FAST CLASSES WILL WALK TOGETHER. WE WILL THEN RUN ALL FAST CLASSES TOGETHER BY JUMP HEIGHT.**

**Off Leash Areas:** Dogs will be allowed off-leash in the lure coursing field and designated fenced-in paddock areas. Retractable leashes will not be allowed at this trial. **And PLEASE pick up after your dogs.**

**Parking:** We ask if you are crating in the building that you leave the up-front parking area for those that are crating in their cars. Day parking is on a first come, first served basis. Please park in designated parking spaces only. Do not block building entrances or fire lanes.

**Directions to Argus Ranch (35612 212<sup>th</sup> Way SE, Auburn, WA 98028):**

From the North/South I-5 or SR 167: Exit at Hwy 18 East, take exit for Auburn-Black Diamond Road East, keep right. Turn right at SE Green Valley Rd. (just past Neely Mansion). Turn right onto 212<sup>th</sup> Way SE. Then turn left into Argus Ranch driveway. Follow signs for parking.

From SR-169 Southbound: Turn right onto Roberts Dr. (in front of coal car). Follow Roberts Dr. approx 4 miles. Turn left at 218<sup>th</sup> St., Bottom of the hill is a stop sign. Go straight across over the cement bridge and take the first left into Argus Ranch driveway.

From SR-169 Northbound: Turn left at SE Green Valley Rd. Follow Green Valley Rd., approx 4 miles. Turn left at 212<sup>th</sup> Way SE, then take the first left into Argus Ranch driveway.

**Crating:** There will be limited crating space inside the arena building along the back wall. PLEASE be courteous of each other and be efficient with your space selection. Please do not block exits/entrances. You may arrive for crating set-up after 5:00 pm Thursday. If you are parking in the area near the Arena, you may not also have a crate inside. This area is reserved for ONLY those people that want to crate out of their cars. Also make sure to not run your car's engine excessively as that puts exhaust fumes in the car next to yours and gasses out those dogs !!!

**Food:** Joan Cook will be providing food for workers. All others, donations would be appreciated.

**EGRC IS GOING GREEN!** Please recycle cans, bottles and plastic in the clear plastic bags that will be hanging on each of the trash cans.

**Photographer:** Nina's Photography will be there capturing the action, so bring your thumb drive ! She will only be there Fri-Sun, and will NOT be there on Monday. Proofs will be posted on her website ([www.ninasphotography.com](http://www.ninasphotography.com)) after the show.

### **B MATCH**

Thirty minutes after the trial ends on **Friday**, there will be a B match. A B Match runs exactly like a show, but with no scoring. You may use toys and you can train in the ring. There will be a time limit per run of 90 seconds. The cost is \$5.00 per run. You must fill out an entry form and entries will be taken day of show. The dog does not have to be entered in the show to run in the match.

***Exhibitors of the EGRC AKC Trial, please note that dogs entered in the AKC Trial are not allowed to practice on any equipment on site. So, if you're dog is entered in the trial you CAN NOT enter the Argus Fun Match unless your Fun Match run is set for at least one half hour after the completion of the EGRC trial on Saturday.***

**MACH, PACH OR PAX:** If you think you'll be earning your MACH, PACH or PAX at this trial, we ask that you please come and remind someone at the Score Table prior to the run you think you'll earn it on. As we are often preoccupied with trial and scoring duties, we may be distracted and wouldn't want to miss celebrating your Championship with you. So again, please come and remind us or send someone to remind us and we'll be ready with a ribbon.
