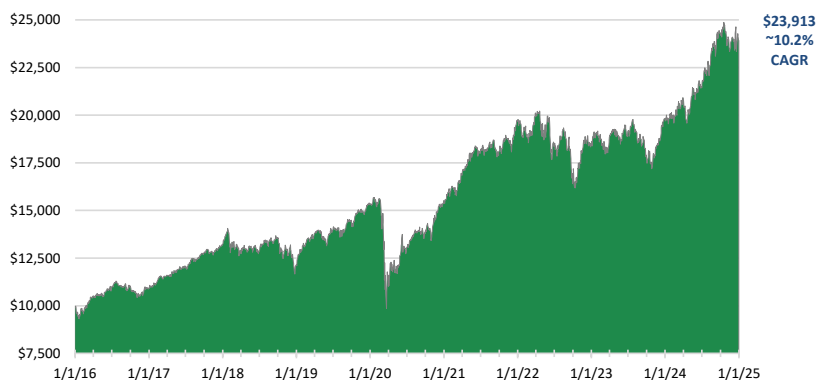


The Global Blue Chip Dividend Strategy has generated a high dividend yield and leading total returns since inception.
