## 2. HAZARDS IDENTIFICATION

## 5. FIREFIGHTING MEASURES

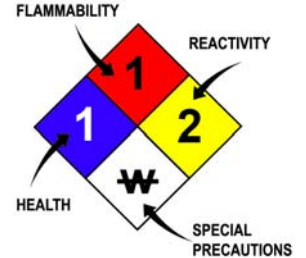
