working on the Islands. Jeff said he does not want to hear that because they are a community-based program and he pays too many tax dollars to the Township. Jim Stevens said that his phone is always ringing about the Islands on West Broad Street. He said that ODOT is responsible for those Islands. Trustee Guyton reminded everyone that the Township was to assume responsibility for the islands once the agreement between Columbus and the Township was signed. Once that was done, the Township was to sign a maintenance agreement with ODOT. Trustee Guyton said that at no time was ODOT supposed to retain responsibility for the islands. Trustee Guyton said that we have received funds that should be used for this purpose as they were negotiated specifically for the purpose. Chairman Cook said that we have not received the monies yet promised for this project. The fiscal Officer stated that it would wipe out our general fund if we have to pay for the beautification of the Islands of West Broad Street. Vice-Chairman Fleshman brought up the JEDD program that we have tried to put into place to assist with the beautification program. Chairman Cook said that we have been working on this issue for about three months. At this time there has been no action taken.

Chairman Cook moved with no further business to discuss to adjourn the meeting. Vice-Chairman Fleshman seconded the motion. Vote taken: Cook, yes, Fleshman, yes, Guyton, yes. Meeting adjourned at 7:39 P.M.
