- d. Key aspects
 - i. Provides quick and direct access to services needed by those experiences of homelessness and low income households (Haircuts, legal services, housing services, employment fair, health clinic and dental)
 - ii. Provides opportunity for community to volunteer and see those struggling in our own community and provide awareness of issues facing these households
 - iii. Ensures that those who are marginalized in the community are aware of the services available to them

4. Agenda Item 4: Action Plan – Next steps

- a. The Rental Action Plan was shared with the group to understand where the energy was for the next steps for action. The two areas of education and working with our municipal partners were identified.
- b. We will work in future meetings to identify what the next steps will be for these two subgroups. Some initial thoughts were to follow up on the comprehensive plan comments to see what was included or not; work to attract additional housing developers willing to build the housing stock needed in the community based on data and community assessments; communicate and build greater understanding in the community around housing.
