# MDARD Offers Free West Nile Testing for suspected horses.

In partnership with the Michigan Department of Health and Human Services and Michigan State University's Diagnostic Center for Population and Animal Health, the Michigan Department of Agriculture and Rural Development is currently offering to pay for West Nile Virus testing for equine which have developed a sudden onset of neurologic signs. Neurologic signs can include stumbling, inability to rise, difficulties urinating and/or defecating, blindness, seizures, and/or having a droopy lip and/or eyelids. Testing involves either a sample of blood if the animal is alive or if the animal is deceased, collection of the brain/head. If the brain/head is collected, the animal will also be tested for rabies and eastern equine encephalitis at no expense to the owner. Equine owners with equine, with a sudden onset of neurologic disease or prior to death were showing signs of neurologic disease, interested in testing are advised to contact their veterinarian. Testing is completely voluntary and must be done through a licensed veterinarian. As a reminder, WNV, which is transmitted through mosquito bites, is commonly found in Michigan and there is a highly effective vaccine available for horses. WNV is a reportable disease; to report a case of WNV in an animal, contact MDARD at 800-292-3939 (daytime) or 517-373-0440 (for after-hours emergencies). 
#### EQUINE ACTIVITY LIABILITY: Signed by the Governor

Governor Rick Snyder signed PA 87 of 2015, the Michigan Equine Liability Act on October 6, 2015, effectively protecting those hosting equine activities from law suits if an accident occurs, unless there is willful neglect. Until this Act, a riding stable, racetrack, park, or horse farm owner was liable even for natural occurrences that could cause an accident, such as downed trees, a rodent hole or bee's nest. The act is



retroactive to September 21, 2015, and now provides more protection for 35,000 Michigan Equine Partnership (MEP) members and equine operations in Michigan.

"Our MEP members, including Attorney Julie Fershtman, have worked diligently with State Representative Joel Johnson for this change," said MEP President Aaron Rice.



### Michigan International Horse Park Interest Revived

There is untold value in a Michigan Horse Park for all breeds of equine and all types of activities. A Horse Park for equine enthusiasts will add to the economic recovery of Michigan through job creation in the region where it is established. # **Horse Racing**

The Horse Racing industry continues to work toward an agreement that tracks, horsemen, breeders, etc., along with the legislature and Governor can embrace that will keep live racing a viable industry in Michigan. There currently are two bills introduced in the legislature and work groups continue to reach consensus on the issues so that we may move forward together. "Michigan's 155,000 horses are estimated to be worth \$531 million - we need to encourage outdoor activities and growth in this industry, and this Act is a step in the right direction."

Michigan horse people have \$4.35 billion equine related assets, and the economy sees about \$460 million in equine related expenditures annually, with approximately \$150 million generated in annual income.\*

"This change now brings Michigan in line with 38 other states for liability protection for equine enthusiasts," said Rice. "This support from Michigan's legislature and Governor Snyder strengthens and protects the equine industry in Michigan. People can now re-invest in their operations and enjoy horse related activities without constant worries about losing their farms because a horse steps in a ground-hog hole."

House Bill 4175 amended Section 5 of the Equine Activity Liability Act. That section lists circumstances when Section 3 does not apply and when an equine activity sponsor, equine professional, or other person remains liable. (See Background Information.) Equine activity sponsors include both for-profit and nonprofit organizations, including a pony club; 4-H club; hunt club; riding club; school- or collegesponsored class, program, or activity; therapeutic riding program; stable or farm owner; and operator, instructor, or promoter of an equine facility including, but not limited to, a stable, clubhouse, pony ride string, fair, or arena at which equine activity is held.

The bill reworded Section 5(d) to the following:

... a person who "Commits an act or omission that constitutes a willful or wanton disregard for the safety of the participant, and that is a proximate cause of the injury, death, or damage."

#### 2016 EQUINE LEGISLATIVE GOALS

#### Create an Equine Education and Marketing Program

 \$5.00(+/-) per ton of feed manufactured. Funds will be placed in Equine Development Fund at Michigan Department of Agriculture. Applied at point of manufacturing - not feed store/elevators. Consumers pay approximately .13 cents per 50 pound bag. A Governor appointed committee would oversee the program. Approximately \$400,000 will be generated for the program.

#### **Horse-Drawn Vehicle registration**

Representative Joel Johnson has introduced HB 4042, which will require registration fees on horse-drawn vehicles. This bill will allow counties to levy and earmark the funds from this legislation. The bill has been assigned to the House Transportation committee. The following is the bill in its entirety for your review:



A bill to amend 1949 PA 300, entitled "Michigan vehicle code," (MCL 257.1 to 257.923) by adding section 801k.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT: SEC. 801K. (1) A COUNTY, BY ORDINANCE, MAY CHARGE A FEE NOT TO EXCEED \$50.00 FOR REGISTRATION OF A HORSE-DRAWN VEHICLE WITHIN THAT COUNTY. A COUNTY MAY CHARGE THE FEE AUTHORIZED IN THIS SUBSECTION ONLY UPON THE APPROVAL OF A MAJORITY OF THE ELECTORS IN THAT COUNTY VOTING ON THE QUESTION AT AN ELECTION HELD ON A REGULAR ELECTION

date as provided in section 641 of the Michigan election law, 1954 PA 116, MCL 168.641.

#### Save Michigan Horseracing Industry

The package to include:

- Amend the Michigan Horse Racing Act, 1995 to allow for other forms of pari-mutuel racing
- Allow for Advanced
  Deposit Wagering



- Negotiate the Gaming
  Compact with Native American Casinos with impact fee to Equine Development Fund
- Industry preference Regulated by MDARD with Racing Commissioner

(2) A fee charged under this section shall be used only for road repair as determined by the county.

(3) As used in this section, "horse-drawn vehicle" means a nonmotorized vehicle powered by an animal within the equine family.

This legislation is not yet scheduled for a committee hearing. Representative Johnson continues to pursue having a hearing on the merits of the bill.

## Feeding the Foal and Lactating Mare

# Providing adequate nutrition is important to maintaining a healthy mare and growing foal.

Milk is the sole nutrition for the first 2 to 3 months of the foal's life. By 4 months of age the foal is over 40% of its final adult size. That requires calories to support growth, protein to build the framework for all tissues, and vitamins and minerals to support cell division, bone, enzyme systems and blood building.

#### A foal's health is dependent on the mare's nutrition

Mares who receive inadequate calories and/or protein can show a very dramatic weight loss after foaling, which indicates a significant nutritional deficit. When this happens, the mare's body breaks down her body tissues to supply calories and protein.

Bone and tissue stores of mineral stores are depleted to supply the milk, compounding her nutritional challenges. If the mare has poor body stores of minerals like Copper and Zinc, the foal will not receive adequate nutrition.

Compared to her baseline adult needs, a wide range of the lactating mare's nutrients require escalation, including a protein increase of 144% and a Calcium and Phosphorus increase of 300%.

#### Increasing nutrient density to meet lactation needs

Because of the large discrepancy between calorie needs vs. protein, minerals and vitamins, simply feeding more to meet calorie needs won't get the job done.

To cover her protein and mineral requirements, add another 1 to 1.25 pounds of a 40 to 45% protein supplement and 1 to 1.5 additional doses of her usual mineral supplement, or 2 pounds per day of a combined 25% protein and mineral supplement.

#### What's good for the mare, is good for the weanling

Getting input from an equine nutritional expert will help ensure a healthy mare and foal. As an additional incentive, this lactating mare diet also works to account for the identical, high nutritional needs of weanlings, just adjusting for amounts fed.

For example, a weanling at six months of age will need to eat about half as much as his dam did while she was nursing. Use the same diet she was fed cut in half, and you also have an ideal diet for your young horses.

Note: If you are not sure if your mare has received adequate protein you can help support production of adequate quality colostrum by supplementing her with high quality protein like whey and proven, safe natural immune supporting digestive ingredients like Arabinogalactan, Mannanoligosaccharides and Fructooligosaccharides.
