## **Guidelines / Deadlines:**

\*State Regent will send the Slate of Officers and ask for any nominations from the floor for State Office and the 2023 Nominating Committee by Thursday, February 18. She will instruct the Court Regents to announce the slate to her Court members and to inquire if anyone is interested in running 'from the floor.' The Court Regent is the only member who can nominate a candidate from her Court for the Nominating Committee. She should email the name of the candidate, the name and number of the Court, and the City to the State Regent.

\*The State Regent must receive all paperwork to run from the floor for State Officer or the Nominating Committee by Monday, March 8.

\*All five State Officers will meet in person to verify candidate paperwork, create and mail ballots to Court Regents. Ballots for State Officers, 2023 Nominating Committee and 2021-2023 State Project will be mailed out by Monday March 15.

\*The Court Regent is responsible for getting the ballots to the delegates in her court. The Court Delegates must be registered in order to vote. After voting, the Delegate puts her ballots in an envelope and returns to their Court Regent. The Court Regent is to put all ballots from her Court in one envelope and mail them to the State

Regent - must be postmarked by **Monday, March 29**.

\*The State Regent will receive mailed ballots (to remain sealed), bring them to the Convention and give them to the Election Committee Supervisor (the National Supervisor/Director.)

\*The State Officers and National Supervisor/Director will meet in person (in Belfield) to host the State Virtual Convention.

\*All registration forms sent to 2<sup>nd</sup> Vice State Regent - received by **Wednesday, March 31**.

\*Local Courts mail donations for Vocations and current State Project FOCUS to State Secretary to be by Monday, March 15.

## Saint Gianna Maternity Home Warsaw, North Dakota

## "One Mother, One Baby, One Family at a time."

St. Gianna's Maternity Home was selected as the North Dakota Catholic Daughter's State Project once before at the beginning of the home's inception in 2003 but is in need of funds especially for renovation of part of the building. They have been saving up funds to complete the "Pietro Molla" entrance and are hoping to improve and make handicap accessible the East side of the building leading to the home and especially the Chapel. At this time the entrance is constantly needing attention with possible safety hazards. They are continually cleaning to prevent mold, insects, and even rodents. The income from being a State Project would ensure a much needed entrance and would enable people who come for Mass or tours to get to both the chapel floor and the bottom floor of the home without any steps. With only revenue from donations St. Gianna's welcomes pregnant women of any

age who are experiencing a crisis pregnancy and provides safe shelter, food, clothing, education, and counseling. It is their belief that every unborn child is a gift from God and has a right to life and that every pregnant woman has the right to give birth with dignity. What better alternative is there to abortion?

These mothers, most of them young, get help in finding the right solutions for themselves and their child. St. Gianna's assists with finding a medical doctor and providing the resources for the mental, physical, and emotional well-being of each woman and child. There are opportunities for these mothers to take classes and continue their education.

Many mothers who arrive on their doorstep come having experienced fear, rejection, and loneliness. It is the purpose of St. Gianna's to bring these mothers the love of Christ and the joy of experiencing that love. From even the most difficult situations, with God's grace, good things can and have been happening at St. Gianna's.

The mission of Connect Medical Clinic is born out of a desire to walk with those facing an unplanned pregnancy, instead of being alone, afraid and disconnected. Patients at Connect Medical Clinic discover they are strong, empowered and surrounded by a community of support.


