McCaleb has talked to Greene County Sheriff; and does not want to rely on Greene County Deputies to show up; we need fast local help.

Icenhower stated there is still 24 hour coverage. One officer position was terminated from police department budget. Leaving five officers.

Danderson stated there should be 30 hours of overlap every week in police department. McCaleb asked if it will still be 24/7 coverage if an officer is on vacation or sick? Icenhower stated that would be up to the Chiefs scheduling.

Ted Wolf, 70 W. Draper stated he has attended the last two or three budget sessions and thinks they did a good job but would like the board to revisit getting the sixth officer back in the budget as soon as possible. According to my neighbors you can't have too many officers.

EMERGENCY MANAGEMENT UPDATE. (Ault)

Chairman Richard Avery and Dayna Ault talked to Tom Faulkner about becoming OEM Director. Avery reported Tom turned down the Resource Officer position at the school due to uncertainties with COVID etc. to retain his current job. Tom has agreed he would accept the Director of OEM and Greg Porter the current director has agreed to become the assistant to keep a smooth transition.

Icenhower stated that it had already been agreed upon at the last meeting to connect the School Resource Officer position to the OEM Director position.

Ault stated that it had been discussed, but everyone agreed to try and get Tom Faulkner to reconsider taking the position; and then if he refused, the city would look at combining the position. Ault stated the School Resource Officer will need to be trained and it will take approximately a year to complete. Tom Faulkner agreed to help the new Resource Officer obtain his training, and will be okay turning the OEM Director position over to him next year. Ault has great concern the city will lose the OEM grant because the new School Resource Officer will not have the qualifications and certification. Icenhower stated the city will not lose the grant. Icenhower stated the OEM Director should be linked to the School and he has already discussed it with Mr. Bell. All the OEM equipment is at the school. Mallard asked if it had to stay at the school. No, all the equipment, including truck belongs to the city.

Danderson wants to wait to see who the school hires to take both positions before any decision is made.

Icenhower stated Tom and Greg are not going anywhere and will continue to help the city as long as necessary.

Danderson stated the board should wait for the school to make a hiring decision before this board moves forward with an appointment.
