#### SCOTTSDALE RANCH ANNUAL ASSESSMENT Due January 1st, 2021! SRCA is pleased to announce that the 2021 Scottsdale Ranch Annual Assessment amount will remain at \$395.00.

The SRCA Annual Assessment is due January 1st We are pleased to announce that the 2021 Scottsdale Ranch Annual Assessment amount will remain at \$395.00. What you need to know:  $\succ$  Invoices will be mailed to all property owners around the second week of December.  $\succ$  To ensure you receive your invoice, the SRCA office must have your current mailing/contact address on file - this is not automatically updated in our system when submitting a change of address to the post office, Scottsdale Ranch must be notified as well. If this information has changed in the past year, please contact our office to update your contact information. This can also be done online by visiting our website at www.scottsdaleranch.org.  $\succ$  All payments are by due January 1, 2021, whether or not you receive an invoice.  $\succ$  Automatic withdrawal (ACH) is available to all our residents. ACH forms can be found on our website at www.scottsdaleranch.org and in our office; either require a voided check. If you have previously enrolled for ACH, your invoice will indicate so.  $\succ$  There is a 30-day grace period providing residents adequate time to make their payment. The assessment fee is not considered late and will be assessed a 10% late fee of \$39.50. Starting February 28, 2021, all accounts not paid will be assessed interest at a rate of 12% per annum, per month until the assessment is paid. # LANDSCAPE

The year of Covid-19 has certainly been different for all of us as we have adjusted to mask and social distancing. But here in Scottsdale we had to add one more ingredient in trying to maintain our landscaping. The Dry Summer Heat

Scottsdale has seen 55 plus days of temperatures over 110 degrees shattering the record of 33 days in 2011. It has been extremely hard on CdC's shrubbery and trees throughout the community. We have lost four mature trees and several shrubs with a few more showing signs of heat related stress. We are in the process of removing and replacing all damaged or dead trees and shrubs. The tree replacement is complete. If you have shrubs that have died, please contact us via reply to this email to schedule replacements. Desert Villa has done a good job this summer in keeping the community looking the best it possibly could look, considering the extreme heat.

We are also asking all homeowners to check your backyards for heat related damage. We have neighbors reporting dead trees and overgrown shrubs in backyards overhanging common walls. Out of town residence please have someone check your backyard to maintain overgrown shrubs or removal of dead shrubs and trees.

In addition, if you are a snowbird and have someone tending to your fruit trees in your back yard while you are away, it is important that you are certain this service is being done. This past summer, a number of resident's fruit trees were left unattended causing fallen fruit which attracts roof rats. If fruit trees are left unattended, please notify us via email or voice mail and we will work with the homeowner to get the trees trimmed. This can become a major problem if left unattended and if we all work together, we can keep roof rats out of our community. Thank you all for your cooperation!

### **HOUSEKEEPING ITEMS**

**Dogs on Leash:** Please be reminded the City of Scottsdale does have a leash law which requires all dogs to be on a leash when outdoors. If you feel your dog needs to run, we suggest the wonderful dog parks the city has installed for dogs to run and play. Also, a quick reminder: Please pick up after your dogs and please don't use your neighbor's garbage cans as a deposit canister. Our attractive community draws walkers from other areas – some with dogs and some without. If you see someone who is not picking up after their dog, kindly remind them of our rules. If they are not receptive to your suggestion of picking it up, please feel free to contact the Scottsdale police dept and they will be happy to pay the dog owner a visit. Our residents have done a great job of tending to their pets and its only fair to ask others who are walking through our community to do the same.

**Trash Cans Reminder:** Scottsdale Ranch and CDC ask that garbage cans are to be placed at the curb no earlier than 5pm on the day before pickup. Please remove the same day as pickup as soon as reasonable possible.

**Pool Rules and Pool Area:** Thank you for adhering to the Maricopa County Covid rules for communal pools this summer. The pool has been a great asset to all who have been isolating to enjoy a great break from the heat. We are still under the mandates from May and June. Rules are posted on the gates as reminders to all residence. Please be reminded to limit the number of residence when the pool is crowded. We are still requesting residence only at this time, (No Guests Please)
