EXECUTIVE DIRECTOR, CROSSROADS SAFEHOUSE, FORT COLLINS, CO

I led and worked with the staff and clients of Crossroads Safehouse, the domestic violence shelter tasked with serving all of Larimer County.

My Safehouse duties included training; fundraising; oversight of 35 paid staff and 150 volunteers; client interviews, assistance and advocacy; programmatic development; and community education. The executive director's financial responsibility involved annually raising \$1,750,861 to support the Safehouse. (In 2004 the budget had been \$614,000, down \$34,000 from 2003.)

Safehouse enhancements, 2005 to 2012, included the creation of an Outreach Center; six-county Legal Representation Division ("Bringing Justice Home"); a 25-Unit Transitional Housing Program ("HOME"); Teen Dating Violence Institute; Houses of Hope Faith-based Initiative; toll-free Domestic Violence Hotline (1.888.541.SAFE); Department of Human Services Co-location Advocacy Program; completion of a \$6,134,362 Capital Campaign; and the opening of a new 29,000 square-foot Crossroads Safehouse in 2011.

EXECUTIVE DIRECTOR, PACE WOMEN'S JUSTICE CENTER (PWJC), PACE SCHOOL OF LAW, WHITE PLAINS, NEW YORK (SINCE 2016: THE ELISABETH HAUB SCHOOL OF LAW AT PACE UNIVERSITY)

I created and conducted intimate partner violence trainings for attorneys and law enforcement professionals throughout New York State. I provided about 20 expert witness trainings. I also offered numerous presentations focusing on evidence-based prosecution techniques, federal domestic violence legislation, family law, and protection order issues, at the rate of over three trainings per month, for a total of 360 trainings for over 13,000 attendees.

My PWJC duties included teaching; personally representing domestic violence victims in civil and criminal matters ranging from harassment to homicide; submitting *amicus* briefs and statements of interest on appellate issues as a domestic violence expert; and supervising a staff of 15 attorneys and many law students.

I also conducted a two-week domestic violence training program in Tanzania, Africa, in 1998 for the United States Information Agency.

Center enhancements, 1994 to 2004, included the creation of the Family Court Legal Program (with satellite offices in the Westchester County Courthouse and the Yonkers Family Court, where Center staff and law students annually provide legal counsel to over 1,000 domestic violence victims); a Moderate Means Panel of Attorneys; DETER (a 24/7 legal service with local police departments responding to 911 domestic violence calls); and memberships on many committees, boards, and work groups dedicated to domestic violence intervention initiatives.

I have spoken on national television and radio programs (e.g., on Court TV, NBC and CBS News) concerning domestic violence, sexual assault, child abuse, and victim and offender dynamics. And I have contributed to a variety of intimate partner abuse media print pieces.

LEGISLATIVE TESTIMONY

I have testified five times at Colorado or New York State Legislative Committee Hearings. Topics have included the Domestic Violence Factor Law, Prosecuting Domestic Violence Cases, Shared Parenting, and Confidentiality. I have also testified before the New York State Domestic Violence Fatality Review Board.
