## **Jennifer Harlow Jacobs:**

She is also part of the Children's Internet Task Force since 2010, that covers all of Orleans County. She is a youth Advocate for Umbrella that teaches about healthy relationships and internet abuse. She has had an extensive amount of training in all fields.
- Jennifer is running for Orleans County Sheriff. She feels that building healthy relationships with the communities is very important. She would like to see the Sheriffs Department become the "go to" Department, and in the future have their services available to people 24/7, if she is elected. She is extremely passionate about her job, so even if she is or isn't elected Sheriff, she will continue to be involved in the Orleans County District to keep adults and children safe in the schools and communities.

# **Other Business:**

- Update: Sandy spoke with Howard Manosh about the Asbestos Project. They are still waiting on financial approval and are still investigating possible sites to take the material. Thus far, Swanton, Milton, Newport, and St. Albans have showed interest. We will be updated again when there is new information.
- Update: One side of the Town Garage has been replaced. The other side towards the sandpile will be investigated to see if that side will also need to be replaced, and the picture window will be replaced with a smaller window.
- The Board Chair signed, and approved Truck Weight Permits for the following: James A Donavan Trucking.
- Construction for the Blodgett Bridge will be starting soon. The Road Commissioner will be hiring a crane to lift the bridge and put it back when finished. He will also be putting 6-inch concrete decking rather than hemlock to make the construction of the bridge last longer. The Selectboard gave the go head to start as soon as he can.
