# VIII. Vice Presidents' Reports

#### A. San Luis Obispo County Mike Thompson 5 min SLODSA did well in the last election. The 2 candidates they supported for

BOS won. SLO DSA now has 3 out of 5 board members who should tend to be supportive of the DSA's objectives.

Mandatory OT in the jail is a HUGE issue right now. Hiring has not kept up with the increase in jail population.

#### **B.** Santa Barbara County Chris Corbett

Chris Corbett not present; Javier Antunez (SBSO) SBCDSA recently approached by the county, yet again, to talk about possible concessions. DSA agreed to meet with county reps, but we are locked in to a contract until February 2015, and have no remaining raises. The ONLY possible concession that could be made at this point without taking any further money out of its members' pockets, would be an agreement by the DSA to continue the 2.4 hour "give-back" that is set to sunset February 2012. Membership support of such a concession would be next to impossible.

The main jail continues to suffer from severe understaffing. 12 Deputy Sheriffs will soon be transferred to custody operations, to augment staffing. This temporary reassignment could last up to 12 months.

### Eric Beecher (SBPD)

Issues between SBPOA and the Chief continue. Recently, the POA had to sue the department over motor trouser issue. Chief did not like the way the new "safer" pants looked and wanted to go to the old style trousers. POA is currently working with a citizens group in an effort to move the Chief from under the City Administrator's oversight, to the City Council's. This potential move has not been well received by the Chief. The POA believes this will result in more accountability and transparency on the part of the chief. The City Council has currently been neutral on the issue. So

far the push has been well received by the public. SBPOA will soon ask PORAC for support on the issue.

### Tom & Kelly Radzyminski (SMPD)

A ¼ cent sales tax increase meant for public safety, although not explicitly marketed that way, recently passed in Santa Maria. Language in the measure, as to the use of funds for hiring more officers, left ambiguous by current chief. SMPOA would like to thank LDF for recent assistance on a discipline issue.

Guadalupe PD recently voted unanimously (approx 10 members) no confidence in its Chief.

#### C. Ventura County 5 min **Ryan Bates** (not present)

### Don Douglas (VCPPOA)

PPOA membership recently voted to max out PAC contributions for the rest of the year. Part of the motivation for the move was preemptive against the recent attacks on association PACs. PPOA supports bill mandating arming of PO's that monitor high risk offenders.

### Tim Ferrill (VPOA)

Department is also suffering from staffing issues, necessitating the use of alot of mandatory OT. Will be putting recruits through academy soon, for the first time in several years. Wellness program will be put in place soon that promotes health and wellness, while covering injuries, etc. Time bank for employees established recently.

### Larry Johnson (Santa Paula PD)

Negotiations will begin at end of the year. Many takeaways from last contract will hopefully sunset and/or be returned, such as furloughs, tuition reimbursement, etc.
