Treasurers Report

Accounts Receivable Discussion. Mr. Pagnotta inquired about the status of Colorado State Forest Service Payments. Chief Daniels noted that \$27,450 was received this month. A total of \$616,889 has been received this year out of a total billed of about \$860,000. Mr. Asbury inquired about the U.S. Treasury payment. Fire Chief's Report

Statistics. For the month of December 2011, Rye Fire responded to 42 calls (9 fires and 33 EMS) calls for service. In comparison with the previous years this is a 32% decrease from 2010 (62) and a 21% decrease from a five year average of 53. Year to date calls for service show a 16% decrease from the previous five years (2006-2010).

Abby Road Fire. On December 19, fire units responded to a structure fire at 8200 Abbey Road. The house was fully involved and had partially collapsed prior to our arrival. Cause is unknown.
